Investigative Report

- 1. On March 4th, 2021 Investigator [REDACTED] of the [REDACTED] County District Attorney's Office, Special Victim's Unit, was assigned to assist Assistant District Attorney (ADA) [REDACTED] with an interview of [REDACTED] and her allegations of harassment by Massachusetts State Police Trooper Nidu Andrade. It is noted that [REDACTED] is the victim in a [REDACTED] matter, against [REDACTED], currently pending before the [REDACTED] (Docket # [REDACTED]) and that Trooper Andrade was involved in that investigation.
2. [REDACTED] first reported the allegations to ADA [REDACTED] and Victim-Witness Assistant [REDACTED] at the District Attorney's [REDACTED] office. The matter was then assigned to ADA [REDACTED] and Investigator [REDACTED] to investigate and determine if and how this would affect the [REDACTED] District Court prosecution against [REDACTED].
3. Investigator [REDACTED] learned that on or about [REDACTED] [REDACTED] reported to Massachusetts State Troopers [REDACTED], Nidu Andrade and [REDACTED] that she had been physically abused by [REDACTED]. The abuse reportedly occurred while [REDACTED] and [REDACTED] were travelling in a car on [REDACTED] in [REDACTED] (Massachusetts) after having just left the [REDACTED]. As a result of their investigation, [REDACTED] was charged in [REDACTED] District Court (Docket # [REDACTED]).
4. Investigator [REDACTED] learned that [REDACTED] [REDACTED] was now alleging that after the domestic abuse investigation and arrest, Trooper Nidu Andrade had contacted [REDACTED] on several occasions via [REDACTED]. [REDACTED] alleged that Trooper Andrade made inappropriate comments to her in these messages and had sent her a picture of a penis. Investigator [REDACTED] learned that [REDACTED] had provided ADA [REDACTED] with a typewritten statement titled "Statement To Judge" along with screenshots of the messages from Trooper Andrade. The statement and screenshots were provided to ADA [REDACTED] and Investigator [REDACTED] (See attached Addendum A).

5. [REDACTED] statement read as follows:



6. Investigator [REDACTED] reviewed the screenshots of the Facebook messages that [REDACTED] provided. The screenshots read:

This message consisted of a picture of a penis.

7. On March 26th, 2021 ADA [REDACTED] and Investigator [REDACTED] conducted a videotaped interview of [REDACTED]. During the interview, [REDACTED] reported or confirmed that:
- She was there to talk about Massachusetts State Trooper "Nidu Andrade";
 - She first met Trooper Andrade when she was in [REDACTED] because of what had gone on between her and [REDACTED];
 - It was [REDACTED];
 - Initially, 1 trooper arrived, who she identified as Trooper [REDACTED];
 - Trooper [REDACTED] was joined by "Officer Nidu" and another ("tall") Trooper whose name she couldn't recall, shortly thereafter;
 - She was asked "like 2 or 3 times" if she wanted to press charges and [REDACTED];
 - She was eventually "[REDACTED]" to say "[REDACTED]" to [REDACTED];
 - She and Trooper Andrade started talking via [REDACTED];
 - During the conversations she was asked about her bra size, was told he was off-duty, was told she could talk to him about anything and was asked to send pictures of her "parts", all of which she said [REDACTED] to adding [REDACTED];
 - [REDACTED];

- k. [REDACTED] said the contact by Trooper Andrade started around "[REDACTED]" and it was only through [REDACTED];
- l. She thought "[REDACTED]";
- m. She decided to report it "[REDACTED]";
- n. She "[REDACTED]" and that Trooper [REDACTED] told Trooper Andrade tried to talk her into pressing charges because Trooper Andrade spoke [REDACTED];
- o. She did not give Trooper Andrade her telephone number;
- p. There was no contact between the incident in [REDACTED] and [REDACTED] when Trooper Andrade began trying to contact her via [REDACTED] after having found her on [REDACTED] even though her account was set to [REDACTED];
- q. [REDACTED] said she took a screenshot of the initial contact by Trooper Andrade;
- r. [REDACTED] said that she last heard from him in February when he wished her good luck and said he intended to delete his [REDACTED] to which she said she did not reply;
- s. When asked, [REDACTED] said [REDACTED];
- t. When specifically asked, [REDACTED] said she took screenshots of all communications with Trooper Andrade in their entirety, both his and her comments;
- u. When asked, [REDACTED] said that she had never spoken with him by telephone or in person, other than the night at [REDACTED];
- v. [REDACTED] said that the communications between she and Trooper Andrade were when he was off-duty at which time ADA [REDACTED] located a particular message indicating such;
- w. ADA [REDACTED] located the message(s) regarding her bra size and [REDACTED] confirmed she did not send him a picture of herself when he asked her to;
- x. [REDACTED] confirmed that she received a photo of a penis which she said was his penis and which she never asked for. She confirmed this was the only picture she received from him;
- y. [REDACTED] again said her last contact was in [REDACTED] (2021) when he wished her good luck;
- z. When asked, [REDACTED] said the penis in the picture was Trooper Andrade's, adding "[REDACTED]".
NOTE: It is not known how [REDACTED] knows that or if she was speculating;
- aa. [REDACTED] confirmed for ADA [REDACTED] that she had given "limited consent" to examine the [REDACTED] messages and screenshots on her cellphone.

8. As part of the investigation, [REDACTED] turned over her cellphone for the purpose of extracting any evidence that supported [REDACTED] allegations, including the screenshots of the [REDACTED] messages she received. Detective Sergeant [REDACTED], a trained/certified examiner, conducted the extraction and provided his Extraction Report along with extracted evidence to Investigator [REDACTED]. The extraction report is attached to this report and the thumb drive containing said report will be preserved by the District Attorney's Office. (See Addendum B).

9. Investigator [REDACTED] reviewed 5 screenshots of conversations allegedly between [REDACTED] and Nidu Andrade that were extracted by Sergeant [REDACTED] and attached to the report. The conversations included the following:

10. Also extracted from the cellphone were 2 records of [redacted] messages dated March 3rd, 2021 at 7:09am and 10:18am. The record indicated it involved participants [redacted] (Nidu Andrade) and [redacted] ([redacted]). The first message said "Good luck with the court thing be later this month". The second message said "If you have any questions let me know before I deactivate my [redacted] again".

NOTE: These messages were sent on [REDACTED], the day after a scheduled court date of the [REDACTED] matter.

11. As part of the investigation, Investigator [REDACTED] submitted a Preservation Request to Facebook, which was assigned case # [REDACTED]. The request was for records relative to telephone # [REDACTED] as well as Facebook Messenger accounts [REDACTED] and [REDACTED] for the time period between October 1, 2020 and March 1, 2021. (See attached Addendum C).

12. On Sunday, April 11th, 2021 Investigator [REDACTED] received a text message(s) from [REDACTED] [REDACTED]. In the messages, [REDACTED] questioned the date of her next court appearance on the Attleboro case. In the messages on that date, [REDACTED] said:
