- 1. Beginning in 2023, D & E Pizza and Subs located at 618 Washington St started to become the target of several incidents, including but not limited to harassment. Some of these incidents led to the Canton Police Department conducting several criminal investigations, and continue to present day. These investigations have led to several individuals being charged criminally with misdemeanors and/or felonies.
- 2. As a result of one of these incidents, in late October of 2023, I began an investigation into one particular matter. This investigation later led me to charge an individual with violations of MGL Chapter 269 Sec. 13A False Report of Crime to a Police Officer and MGL Chapter 268 Sec. 13B Obstruction of Justice.
- 3. D & E Pizza and Subs is a family business owned and operated by Chris Albert. His son Colin Albert frequents the business. Both Chris and Colin Albert are witnesses in the ongoing Commonwealth vs. Read trial. Prior to the trial commencing in 2024, Colin Albert testified before a Federal Grand Jury. Also, prior to the trial, both Chris and Colin Albert testified before a Massachusetts Grand Jury. Their grand jury testimonies were given prior to March of 2024. They both appeared on the Commonwealth vs Read witness list. Both Chris and Colin Albert later went on to testify as witnesses for the Commonwealth during the Commonwealth vs Read trial.
- 4. On January 29, 2022 John O'Keefe was discovered outside on the property of 34 Fairview Rd, Canton, MA. John O'Keefe was later declared deceased by medical professionals. As a result of his death, Karen Read was later criminally charged, and later indicted by a grand jury for second degree murder for her role in his death.
- 5. Later in 2023, conspiracy theorists claimed that on the night of Friday, January 28, 2022 into Saturday, January 29, 2022. Colin was inside of the house at 34 Fairview Rd at the same time as John O'Keefe and that Colin Albert murdered John O'Keefe. Both of these claims were completely disproven via testimony given by several witnesses, including Colin Albert, who testified under oath during the Commonwealth vs Read trial. Every witness that was present inside of 34 Fairview Rd on January 29, 2022, and later testified under oath, all stated that John O'Keefe never entered the residence. Massachusetts State Police Trooper Guarino, also testified that GPS data from Joh O'Keefe's cell phone, showed that he never entered 34 Fairview Rd.
- 6. This testimony and evidence made it impossible for Colin Albert to be a suspect in John O'Keefe's death, contrary to the conspiracy theory that Colin Albert murdered John O'Keefe. This conspiracy has led to various harassment and littering incidents, including but not limited to use of the tagline, "COLIN DID IT!" stamped in red ink on counterfeit \$100 bills and the same phrase attached to yellow rubber ducks via a sticker. These incidents have led to a social movement that has harassed Chris and Colin Albert, telling them to, "tell the truth," and they cannot, "duck the truth," about John O'Keefe's death. Both have given testimony contradictory to this conspiracy theory; therefore, these incidents are intended to persuade both of them to alter their previously given testimonies.
- 7. In July of 2024, the trial ended in the jury being deadlocked and a mistrial being declared by Judge Beverly Cannone. Therefore, this is still an ongoing matter that has not yet been fully adjudicated and a new trial is scheduled to begin in January of 2025. Chris and Colin Albert are both expected to testify as witnesses for the

Commonwealth in this next trial as well.

- 8. This investigation, as further described below, has been an ongoing investigation for approximately 6 months. It has included letters of preservation, the execution of search warrants, surveillance which included my own observation of several crimes committed, witness statements, some of whose identity is otherwise being withheld at this time due to fear of retribution, similar to that of what is further described throughout this investigation.
- 9. On Wednesday, March 6, 2024, (1st documented incident) at approximately 4:30PM, the Canton Police received a report of counterfeit \$100 bills being littered in the area of the intersection of Washington St at Revere St. This location is approximately 100 yards from D & E Pizza & Subs. Upon Officers Mei and McDonald's arrival to the area, they were handed approximately 20 counterfeit \$100 bills in an envelope that had, "Justice for BPO John O'Keefe # 2490 Last Watch 02/29/2022," stamped on the front. Additionally, "COLIN DID IT!" was stamped on the back. According to the witnesses that provided officers the envelope containing the counterfeit money, they stated the incident occurred at approximately 2:00PM 2:30PM. Further investigation by officers for video surveillance cameras of the area, yielded no results. Later upon examination of the counterfeit money, I took note of the fact that the date of 02/29/2022 was incorrect. John O'Keefe's date of death is 01/29/2022.
- 10. On March 13, 2024, (2nd documented incident) at approximately 2:44PM, the Canton Police Department received another report of counterfeit \$100 bills that were littered in front of D & E Pizza & Subs located 618 Washington St. This area can easily be observed by anyone inside D & E Pizza & Subs. Lt. Gallagher arrived on scene and stopped traffic to collect the counterfeit money. The bills located by officers in the area, were the exact same counterfeit \$100 bills that were recovered by officers on March 6, 2024. They displayed "Justice for BPO John O'Keefe # 2490 Last Watch 02/29/2022," stamped on the front and "COLIN DID IT!" stamped on the back. The counterfeit \$100 bills were collected by officers on scene and brought back to the Canton Police Department. Upon closer examination of the counterfeit \$100 bills, the "2" in the month portion of the date 02/29/2022 had been removed.
- 11. On Saturday, April 6, 2024, (3rd documented incident) I was working as a Detective from 7:45AM 3:45PM. Following my 7:45AM 3:45PM shift, I continued working as the Officer in Charge (OIC) for the 3:45PM 11:45PM shift. At approximately 3:25PM, I was made aware of a call the Canton Police Department received in regards to littering in the area of Richard Lewis Formal Wear & Kevin Michaels Men's Fine Clothing located at 626 Washington St.
- 12. As noted in Officer Pascarelli's report, the items littered were counterfeit \$100 bills that were stamped with "Justice for BPO John O'Keefe # 2490 Last Watch 02/29/2022," stamped on the front and "COLIN DID IT!" stamped on the back. In addition to the prop money \$100 bills, were yellow rubber ducks that had a sticker on the bottom that stated, "COLIN DID IT!" Officer Pascarelli noted that these bills were littered along Washington St from the Washington St at Revere St intersection, all the way to the Washington St at Bolivar St intersection.
- 13. "COLIN DID IT!" is a phrase that has been used to accuse Colin Albert of murdering John O'Keefe at 34

Fairview Rd on January 29, 2022, instead of Karen Read. Karen Read is currently charged with second degree murder in the death of John O'Keefe, and is the defendant in the Commonwealth vs. Read trial.

- 14. The 626 Washington St address is in the immediate vicinity of D & E Pizza & subs located at 618 Washington St. As previously noted, the owner, Chris Albert and his son Colin Albert are both witnesses in the Commonwealth vs. Read trial. Both testified in grand jury in regards to the Commonwealth vs. Read trial. Since this incident, they have both gone on to testify as witnesses in the Commonwealth vs. Read trial.
- 15. Canton Police have been called to this area on March 6 and 13, 2024 for the same counterfeit \$100 bills littered on Washington St. This address has been the location for numerous instances of police service calls regarding harassment and unwanted parties in regards to the ongoing Commonwealth vs. Read trial since 2023. These police service calls have to lead to the executions of subpoenas and search warrants that have resulted in criminal charges that include but are not limited to violations of various witness intimidation statutes, including obstruction of justice, and false reports to police officers.
- 16. Officers Chin and Pascarelli recovered approximately 70 of the bills and 6 yellow rubber ducks. These items were returned to the Canton Police Department, where I took custody of them, and later placed into temporary evidence.
- 17. At approximately 5:00PM, I was advised by Officer Pascarelli that while on his way from the Canton Police Department, he noticed several more yellow rubber ducks and counterfeit \$100 bills along Bolivar St, at the Bolivar St at Pine St intersection, and into the area of Cabot Devoll Field area in the parking lot and on Pine St. (Cabot Devoll Field is located at 20 Pine St.) Officer Cavanagh was dispatched to retrieve the ducks and bills. Upon his return to the Canton Police Department I took custody of them, and later placed into temporary evidence.
- 18. As my 3:45PM 11:45PM shift continued I was made aware of several more ducks with the, "COLIN DID IT!" stickers on them being located throughout the Town of Canton at various locations. These ducks were located at the locations as noted above, and in the areas of 1, 3, 6 Burke Dr, 7, 12, 15 Casey St, and 21, 23 Fencourt Rd. These streets are part of the neighborhood that consists of John O'Keefe's residence prior to his death. The exact location is known to the Commonwealth.
- 19. This address is currently the address where his elderly parents reside with two of their grandchildren (John's niece and nephew). Both of these minor children testified in the Commonwealth vs. Read trial. Additionally, more of these ducks were located at various points on York St leading into Stoughton. Officers Chin and Healy recovered ducks on York St. These items were returned to the Canton Police Department, where I took custody of them, and later placed into temporary evidence.
- 20. A confidential witness (who is known to me) was the party that located the ducks in the areas of 1, 3, 6 Burke Dr, 7, 12, 15 Casey St, 21, 23 Fencourt Rd. This confidential witness informed me some of the ducks he provided to me were also collected on York St. In total, the confidential witness provided me with a bag

containing 16 yellow ducks that all had the same, "COLIN DID IT!" sticker attached to them.

- 21. This confidential witness has been the subject of numerous incidents of harassment, confrontations, and doxed online due their support of Colin Albert and the Albert family. Therefore, their identity is known to myself and the Commonwealth as they are fearful for any repercussion(s) that may result due to them providing information, as there has been constant harassment of witnesses at various locations throughout the Town of Canton.
- 22. In total, approximately 70 counterfeit \$100 bills stamped with "Justice for BPO John O'Keefe # 2490 Last Watch 02/29/2022," stamped on the front and "COLIN DID IT!" stamped on the back were recovered on Saturday, April 6, 2024. 36 ducks with "COLIN DID IT!" stickers attached were recovered.
- 23. The Canton Police Department has responded to the area of 618 Washington St (D & E Pizza & Subs) for similar incidents. In addition to Chris Albert and members of his family, D & E employees have been the target of numerous incidents of harassment and unwanted parties at his business regarding the ongoing Commonwealth vs. Read trial. This includes harassing telephone calls and other incidents of harassment that has led to execution of subpoenas and search warrants, resulting in people being charged with crimes including, but not limited to, violation of MGL Chapter 268 Sec. 13A Picketing Court/Judge/Juror/Witness/Court Officer, MGL Chapter 268 Section 13B Intimidation of Witness/Juror/Police/Court Official, and MGL Chapter 269 Section 13A False Reports to Police Officers. These incidents have not only caused emotional injury to the Alberts, but particularly economic injury to the family business.
- 24. Later upon further examination of the evidence recovered on March 6th, March 13th, and April 6th, 2024, I took note of particular differences in several of the counterfeit bills recovered.
- 25. The counterfeit bills recovered on March 6, 2024 had, "Justice for BPO John O'Keefe # 2490 Last Watch 02/29/2022," stamped on the front. "COLIN DID IT!" was stamped on the back. The date was obviously incorrect, as John O'Keefe's date of death was 01/29/2022 (January 29, 2022). Additionally, the date of 02/29/2022 (February 29, 2022) never existed, as 2022 was not a leap year.
- 26. Counterfeit bills recovered on March 13, 2024 and April 6, 2024, were identical. They appeared to be nearly identical as the counterfeit bills littered on March 6, 2024. However, the counterfeit bills recovered on March 13th and April 6th, appeared to have the "2" in the month portion of the date 02/29/2022 had been manually removed.
- 27. A consistent feature of all the counterfeit bills, was on the front on the bill, the font and ink appeared to be the same on every bill, whether or not they contained the entire incorrect date of 02/29/2022 or had the "2" in the month portion removed. I took notice of the fact this stamp did not appeared to be printed. They appeared to have been stamped by hand as they appeared misaligned. They are in different locations and the wording appears to read at various angles.

- 28. Another consistent feature of all the counterfeit bills, was on the rear of the bill. The, "COLIN DID IT!" stamp was the same on every counterfeit bill recovered. These stamps also appeared to have been stamped by hand as they also, appeared misaligned and read at various angles.
- 29. On Sunday, April 7, 2024, 11 of the same ducks, including stickers were recovered from the areas of 2 Wentworth Rd to 33 Wentworth Rd. The ducks were located at various addresses on Wentworth Rd, including that of Massachusetts State Trooper Michael Proctor's private residence, where he resides with his family. This includes his wife and two young children. Michael Proctor is the lead investigator in the ongoing Commonwealth vs Read trial.
- 30. As I began my investigation into this matter, I knew that a witness had seen the counterfeit bills being thrown from a black pick-up truck seen heading southbound on Washington St. Over the next several days, I attempted to locate any black pick-up trucks that may have been in the area of 618, 626, and 635 Washington St area at the same time the incident occurred on Saturday, April 6, 2024.
- 31. Upon reviewing a FLOCK traffic camera located at the Neponset St Washington St intersection, I was able to locate a black pick-up truck that passed the FLOCK camera at approximately 15:25:52 (3:25PM) heading northbound. This black pick-up truck appeared to be a Toyota (unknown model at the time) with a chrome front grill. I took note of the fact that this black pick-up truck did not have a Massachusetts license plate (as required by Massachusetts General Law) affixed to the front of the vehicle. It had a novelty license plate. Specifically, this novelty plate appeared to black and blue, in a pattern, through my training and experience I know is known as a, "thin blue line," plate. I also took notice to what appeared to be a white silhouette of a shape, that possibly resembled a police badge.
- 32. I was later provided video surveillance footage that views outward from the inside of D & E out towards Washington St for April 6, 2024. At approximately 15:26:26 (video display time) a black pick-up truck passes D & E heading northbound. I took note of the chrome wheels and accents as it passed by D & E. Additionally, I took note of a sticker affixed to the upper portion of the rear window.
- 33. At approximately 15:29:40 (*video display time*) a black pick-up truck resembling the truck photographed by the FLOCK camera, appears into frame again, now travelling southbound. I immediately notice the identical front chrome grill and wheels as being the same, and the black and blue, "thin blue line," novelty license plate affixed to front.
- 34. On Tuesday, April 9, 2024 I was able to obtain video surveillance footage from Elsie's Table located at 497 Washington St Canton, MA. I was able to review several clips of video surveillance footage from various angles that were captured on Saturday, April 6, 2024. Each video captures the black pick-up truck bearing the, "thin blue line," novelty plate, with chrome accents, wheels, and the sticker affixed to the upper portion of the rear window. The display time is off by one hour. The system display time did not adjust for daylight savings time, according to Elsie's Table Manager Eric Hanlon.

- 35. A side exterior camera that captures traffic driving towards Elsie's Table shows at approximately 15:25:47 (display time 14:25:47) the black Toyota (unknown model) pick-up truck entering the frame then travel toward the front of Elsie's Table before it comes into frame of another camera at the front of Elsie's Table.
- 36. The camera affixed to the front exterior of Elsie's Table captures the Neponset St at Washington St intersection. At approximately 15:25:52 (display time 14:25:52) shows the same black Toyota pick-up truck enter the frame of the camera and drive through the intersection. As it drives through the intersection, the same sticker I originally took note of on D &E video, is seen on the upper portion of the rear window. Through viewing this video footage, it appears, the sticker's colors are orange, white, and black. The rear tailgate clearly displays, "TUNDRA." 37. The black Toyota pick-up truck, previously unknown model, was now identified as black Toyota Tundra pick-up truck. A rear license plate is attached; however, it is unable to be determined what it displays.
- 38. On Wednesday, April 10, 2024, I obtained video from the Chai Jewish Center located at 576 Washington St Canton, MA. I was able to review video surveillance footage captured on Saturday, April 6, 2024. The video provided, shows traffic travelling on Washington St, including the intersection of Bolivar St at Washington St. The video shows beyond the intersection including the area directly in front of D & E Pizza & Subs.
- 39. At approximately 15:26:17 the vehicle, now identified as a black Toyota Tundra, bearing the same sticker affixed to the upper portion of the rear window appears into frame. The vehicle is travelling northbound on Washington St, and passes through the intersection continuing on Washington St travelling in the direction of D & E Pizza & Subs. During this time, neither Chris or Colin Albert were present.
- 40. At approximately 15:26:23, when the vehicle is clearly in the area of D & E Pizza & Subs a large amount of paper is littered from the driver side window area of the vehicle, landing on Washington St directly in front of D & E blowing around. The Toyota Tundra continues to drive northbound on Washington St towards the Washington St at Revere St intersection.
- 41. At approximately 15:29:49, the same black Toyota Tundra, bearing the same front novelty license plate reappears now travelling southbound on Washington St. As it approaches the intersection at Bolivar St, it takes a left onto Bolivar St.
- 42. I later obtained video showing at approximately 15:32:01, the same black Toyota Tundra was captured on camera at 35Wheeler Cir driving on Wheeler Cir. Then at approximately 15:32:17, the same black Toyota Tundra was captured on Ring camera at 10 Canterbury Dr driving towards Pleasant St. These streets are part of the neighborhood that consists of 1 Meadows Ave. This was the address of John O'Keefe prior to his death and currently the address where his parents reside with two of their grandchildren (John's niece and nephew). Both of these minor children testified in the Commonwealth vs. Read trial.
- 43. As I attempted to follow the path of the black Toyota Tundra, I later obtained video footage captured by cameras located at several Town of Canton locations provided to me by Louis Jutras.

- 44. On Saturday, April 6, 2024, at approximately 3:34:47PM, the same black Toyota Tundra appears on Town of Canton camera that captures the Bolivar St at Pine St intersection located on the field house at Cabot Devoll Field. The vehicle takes a right onto Pine St.
- 45. At approximately 3:35:03PM, the Town of Canton camera on the other side of the field house captures the same black Toyota Tundra pull into the Cabot Devoll Field parking lot, drive around the parking lot, and leaves taking a left onto Pine St at approximately 3:35:58PM.
- 46. At approximately 3:36:49PM, a Town of Canton camera, at the Transfer Station, located at 87 Pine St, captures the black Toyota Tundra, travelling on Pine St, heading towards Stoughton.
- 47. Further investigation into the black Toyota Tundra determined that it was a later model Toyota Tundra, third generation, produced in 2021 or later. Several searches of the Massachusetts Registry of Motor Vehicles via the Criminal Justice Information System (CJIS), showed several later model black Toyota Tundra pick-up trucks registered in Canton and surrounding areas.
- 48. Through the collection of images and video surveillance footage along with use of the FLOCK camera system, it was determined that the vehicle was in fact a black Toyota Tundra pick-up truck, with a front chrome grill, chrome accents throughout the exterior, an orange, black, and white sticker on the rear window that has been determined to be a Harley Davidson logo with wings protruding from both sides, bearing a front novelty plate of a thin blue line with a white silhouette shape, possibly of a police badge.
- 49. Several images located captured by the FLOCK camera system show the rear of the vehicle. These images aided in determining the orange, black, and white sticker on the rear window to be Harley Davidson logo with wings protruding from both sides. Additionally, these images also captured the rear the license plate of the vehicle. These FLOCK images showing the rear of the vehicle, showed it displayed Massachusetts Commercial license plate bearing, "FNSGYZ."
- 50. A query of the MA Comm Reg: FNSGYZ via the Massachusetts Registry of Motor Vehicles, lists the vehicle as a 2023 black Toyota Tundra pick-up truck assigned Vehicle Identification Number (VIN) 5TFMA5DB3PX067104 and the vehicle is registered to Canton Fence Co Inc, located at 1219 Washington St Stoughton, MA 02072. Canton Fence Co Inc.'s President & Owner is by Richard L. Schiffer Jr. Upon further review of the query results, the address 125 Lake Dr Stoughton, MA 02072 has been previously used for the MA Comm Reg: FNSGYZ registration. A query of 125 Lake Dr Stoughton, MA 02072 shows that Richard L. Schiffer Jr is the only licensed driver at that address.
- 51. A query of vehicles registered to 125 Lake Dr Stoughton, MA via the Massachusetts Registry of Motor Vehicles shows that Richard Lewis Schiffer (the same person as Richard L. Schiffer Jr.) has a 2021 Harley Davidson FLTRXS motorcycle bearing MA Motorcycle Plate: FNSGY.
- 52. On Monday, April 8, 2024, I obtained a clearer image of the black and blue, "thin blue line," novelty

license plate attached to a 2023 black Toyota Tundra pick-up truck parked in the area known as The Village Shoppes of Canton located at 95 Washington St. This clearer image showed that the thin blue line novelty plate displayed a white silhouette of a Harley Davidson logo with the letters, "FLTXRS," through the middle. FLTXRS is the model of the Harley Davidson motorcycle registered to Richard Lewis Schiffer at 125 Lake Dr Stoughton, MA 02072. The Harley Davidson logo with the wings protruding from both sides affixed to the rear window, can be seen in this photo through the front windshield.

- 53. Lt. Gallagher, who was in the area at the time, located the vehicle and began to conduct surveillance on the vehicle. While conducting surveillance of the vehicle, Lt. Gallagher observed Richard L. Schiffer Jr. approach the driver's side of the vehicle, enter the vehicle, and drive away from the area in the black 2023 black Toyota Tundra bearing MA Comm Reg: FNSGYZ. Richard L. Schiffer Jr. has been the only party observed operating and/or entering this vehicle during the investigation.
- 54. On Wednesday, April 10, 2024, at approximately 12:50PM, I along with Detective Barber of the Stoughton Police Department conducted a trash pull at 125 Lake Dr Stoughton, MA. Prior to our arrival at 125 Lake Dr, the rear hopper was emptied. Upon arrival at 125 Lake Dr, there was a single trash barrel out front. The contents of the trash barrel were emptied into the rear of the trash truck, by me, Detective Taylor. The contents of the barrel were 3 trash bags.
- 55. Immediately afterwards, we returned to the Stoughton Police Department. We were followed by Canton Police Department Detective Will Theodore from 125 Lake Dr area to the Stoughton Police Department. Upon arrival at the Stoughton Police Department, the trash placed in the rear of Detective Theodore's vehicle and transported to the Canton Police Department to be searched. After arriving at the Canton Police Department Detective Theodore and I began looking through the contents of each trash bag.
- 56. Items retrieved from the trash contents were an empty prescription medication bottle prescribed to Richard Schiffer, a white box, an Amazon package envelope, and a FedEx package envelope.
- 57. The white box was a white box with partially washed off blue ink that stated, "Justice for BPO John O'Keefe #2490 Last Watch 02/29/2022." The font style is the exact same that was used on the prop money \$100 bills that had been previously littered in the area of D & E Pizza & Subs on several occasions. A sticker attached to the box stated in summary, "JFHY 1000...Birthday." A Google search of this information yields the first link as an Amazon page where this prop money of \$100 bills can be purchased, specifically 1000 pieces of prop money \$100 bills made by a company called JFHY. A photo was taken of one of the prop money \$100 bills, recovered on Saturday, April 6, 2024 next to the white box for comparison on April 10, 2024. They appeared to identical. The Amazon package envelope was addressed to Richie Schiffer jr, 125 Lake Dr Stoughton, MA 02072. This package envelope was empty upon recovery and its contents are unknown at this time.
- 58. The FedEx package envelope was addressed to Rich Schiffer 125 Lake Dr Stoughton, MA 02072 with a phone number of 617-799-7514, a reference number of 16435018, and a tracking number of 2729 3262 3208.

The sender was listed as makestickers.com 18621 81St Ave Tinley Park, IL 60487.

- 59. Detective Theodore contacted a representative at makestickers.com via a phone number he located on their website. Upon his call being answered, he identified himself as Detective Will Theodore of the Canton Massachusetts Police Department. He explained that he was looking to inquire about an order that had been shipped to 125 Lake Dr Stoughton, MA. He was asked to provide a reference number, he provided the reference number from the envelope, which was confirmed to be the reference number that coincided with 125 Lake Dr Stoughton, MA 02072.
- 60. The makestickers.com representative stated that the order sent contained 250, 1-inch clear circle stickers that state, "COLIN DID IT!" This description was similar to the stickers that were located on the bottom of the small yellow rubber ducks. The stickers located on the bottom of the ducks were clear, circular in shape, contained red colored font stating, "COLIN DID IT!" and approximately 1-inch in diameter.
- 61. Additionally, the representative stated a previous order had been placed in December and shipped to a different address. When Detective Theodore asked what the previous address was, the representative asked, "Rich?" Detective Theodore stated to the representative that he was not "Rich," but Detective Theodore of the Canton Massachusetts Police Department, as he previously stated at the beginning of their conversation. The representative then referred him to the president of the company's voicemail. Detective Theodore subsequently left a voicemail for the president of makestickers.com.
- 62. In follow up correspondences, Detective Theodore was able to speak with President of makestickers.com, identified as Adam Feil. During a conversation between them, Adam told Detective Theodore he would be willing to provide customer information requested upon being served legal process. Later in an email, Adam Feil provided a physical address of 18621 81st Ave Tinley Park, IL 60487 and an email of adam@makestickers.com.
- 63. On Monday, May 13, 2024, I applied for and was granted Search Warrant # 2255SW0055 commanding makestickers.com to furnish me additional information in regards to orders sent to Richard Schiffer 125 Lake Dr Stoughton, MA 02072.
- 64. On Tuesday, May 14, 2024, I sent an electronic copy of the search warrant via email to Adam Feil of makerstickers.com. Later on, the same day, I received two PDF files from Adam Feil.
- 65. One PDF copy of Order # 12027682 was noted as **Item 1** for an order of 250, 6-inch by 4-inch Oval Car Stickers that contained the initials, "CFC," with, "cantonfence.com," under them.
- 66. The other sticker in this order was noted as **Item 2** for an order of 250, 6-inch by 4-inch Oval Car Stickers that contained the words, "The Fence Guys," with, "cantonfence.com," under the words.

- 75. Delivered via FedEx on April 4, 2024.
- 76. The order was placed on March 31, 2024 and delivered via FedEx on April 4, 2024. The FedEx envelope located in the trash pull contents from 125 Lake Dr Stoughton, MA 02072 contained this reference number on the shipping label. It also contained the phone number 617-799-7514.
- 77. I took note of the fact the phone numbers listed above are registered to Canton Fence Inc. (781-344-7366) and Richard L Schiffer Jr.'s cell phone (617-799-7514). Additionally, the email address noted above, are the initials for Richard L. Schiffer Jr and the numbers 32059 coincide with his date of birth, March 20, 1959.
- 78. On Thursday, May 16, 2024, at approximately 12:15PM, members of the Norfolk County District Attorney's Digital Forensics Division, Detective Barber of the Stoughton Police Department, along with

Detective Sergeant Lehan and Detective Taylor of the Canton Police Department went to Canton Fence at 1219 Washington St Stoughton, MA 02072, to execute search warrant # 2255SW0054 issued on Monday, May 13, 2024. The purpose of this search warrant was to conduct a download of the Infotainment System data from the black 2023 Toyota Tundra bearing Vehicle Identification Number (VIN) # 5FTMA5DB3PX067104.

- 79. Upon arrival, I spoke with an employee of Canton Fence at the front desk, identifying myself as Detective Taylor of the Canton Police Department. I informed him that I was looking to speak with Richard Schiffer. We went down a hallway to Richard Schiffer's office where I informed him that I was in possession of a search warrant for the data from the infotainment system for his truck.
- 80. I presented him a copy of the search warrant and he stated, "So you want the locations of my truck?" I replied, "Yes." Richard went on to say that the truck really only goes from his house to his work. I stated to him that I had gathered evidence showing him being directly involved with throwing the ducks and counterfeit \$100 bills from his truck, which allowed me to obtain the search warrant I gave to him. He replied, that he only littered and he did not commit a crime. Richard then handed me the key fob to his truck.
- 81. I then brought out the key fob to the Norfolk County District Attorney's Digital Forensics Division technicians to perform their download. I then returned to the office to ask if Richard wanted to talk about the matter at hand. Richard initially stated, "Yes." Upon hearing his reply, I informed he was the subject of a criminal investigation and that I was going to provide him his Miranda rights before continuing our conversation.
- 82. I read a copy of the Canton Police Department Miranda Rights sheet out loud to him in the presence of Detective Sergeant Lehan. When asked if he understood his rights, he checked YES and signed his initials. When asked if he wished to speak with me now, he checked NO and signed his initials. I asked Richard if he meant to check NO as he previously stated he wanted to talk to me. He stated he was aware of this and had nothing to say. Detective Sergeant Lehan and I then exited his office.
- 83. While technicians were inside Richard L. Schiffer Jr's truck I opened the rear driver's side to enter and observe the downloading of the digital evidence of the infotainment data. Upon opening the door, directly in front of me, in plain sight was an uncovered open box. This box contained a yellow duck identical to the ones that have subject of this investigation. Additionally, in the box was an opened brown paper bag. This bag contained 37 yellow ducks that had the., "COLIN DID IT!" sticker attached. Next to this brown paper bag was a clear Ziploc style bag that contained multiple, "COLIN DID IT!" stickers stuck to the inside of the bad. These items were later seized as evidence.
- 84. After several attempts to download the data from the Infotainment System the technicians informed us, they were unable to complete the download, due to a hardware compatibility issue, which is not uncommon as with software updates. Upon determining this, all members of law enforcement and technicians left Canton Fence at 1219 Washington St Stoughton, MA 02072.

85. Upon my return to the Canton Police Department, I entered seized items into evidence. The seized items were noted as...

1 yellow rubber duck

37 yellow rubber ducks with "COLIN DID IT!" stickers attached

1 clear Ziploc style bag containing "COLIN DID IT!" stickers

- 86. From follow up conversations with Norfolk County District Attorney's Digital Forensics Division technicians, it was determined that there were no removal instructions for this particular trim model on the BERLA Mobile Application. Following their conversation with a BERLA support expert, it was determined the Infotainment System Data should be available via a different method. According to the BERLA support expert the Infotainment System Data will be able to be recovered by the Norfolk County District Attorney's Digital Forensics Division technicians using this particular method.
- 87. Having discovered the name Richard L. Schiffer Jr. (a/k/a Rich Schiffer, Richie Schiffer Jr., Richard Lewis Schiffer Jr.) in the course of this investigation, I was able to locate a Facebook profile for Rich Schiffer (https://www.facebook.com/profile.php?id=1667626228). The profile picture is a picture of John O'Keefe wearing a Boston Police uniform. The cover photo is a picture of his residence located at 125 Lake Dr Stoughton, MA 02072.
- 88. Through looking through his Facebook page, it is clear that this is the same Richard Schiffer that is the President & Owner of Canton Fence Inc Co. One of his previously used profile pictures, matches the current profile picture for Canton Fence Co Inc. of himself with his arms crossed wearing black polo shirt (facebook.com/cantonfence). Additionally, the address displayed on the Facebook page is the same as Canton Fence Co Inc. (1219 Washington St Stoughton, MA 02072) and it includes a link to cantonfence.com.
- 90. A Preservation Request was sent to Facebook on April 10, 2024 in regards to his personal Facebook page and Canton Fence Facebook page.
- 91. Upon looking through the Rich Schiffer Facebook page, I noticed several posts he made to his wall or shared.
- 92. In a Facebook post, Rich Schiffer shared on October 8, 2023, is a video clip in which Attorney David Yannetti refers to Massachusetts State Trooper Michael Proctor as corrupt. Trooper Proctor's residence is where a yellow duck with "COLIN DID IT!" sticker attached was located and at several residences throughout his neighborhood.
- 93. In a Facebook post, Rich Schiffer posted on March 25, 2024 at 2:33PM,

"[Pillars] of the community! I'd do with out these pieces of s**t..."

the post contained a picture of members of the Albert family that includes Chris, Colin, and Julie Albert.

94. In a Facebook post, Rich Schiffer shared on February 18, 2024, with the caption,

"IMHO: this is pretty exact!!"

- 95. In summary, the contents of the shared post refer to several parties involved in the Commonwealth vs Read trial. It references Massachusetts State Trooper Michael Procter (the lead investigator in this case), claim Colin and his uncle killed John O'Keefe, and praises Karen Read and Turtleboy. Turtleboy who's true identity is Aiden Kearney, has been indicted on several counts of witness intimidation due to his actions towards several witnesses in the ongoing Commonwealth vs. Read trial.
- 96. Several other Facebook posts and comments were located made by Rich Schiffer, referencing ducks including a picture of a duck that looked identical to the ducks recovered throughout the Town of Canton.
- 97. On Sunday, May 19, 2024, I located a Facebook post made by Rich Schiffer. The post stated,

"Got this visit yesterday .. for passing out propaganda/littering
Only Trying to find out who if anyone put my up to this ..nope total isolated
Beware they have nothing and just grasping at straws
I've never spoken a word to any so called witnesses
Witch hunt after witch hunt"

- 98. This post included a photo of Search Warrant # 2455SW0054 that I provided to him on Thursday, May 13, 2024.
- 99. Propaganda is defined as, information, especially of a biased nature or misleading nature, used to promote or publicize a particular political cause or point. His own admission establishes that he was aware that the information being put forth by him was designed to intentionally mislead others in an attempt to promote false information in an attempt to further harass members of the Albert family, who testified in the Commonwealth vs. Read trial.
- 100. This Facebook post from May 19, 2024 was the second time he admitted to littering the ducks and counterfeit \$100 bills. As noted earlier in my investigation, on Thursday, May 16, 2024, when I presented him with Search Warrant # 2455SW0054, he stated, that he only littered and did not commit a crime.
- 101. As noted throughout this investigation, the items littered, the counterfeit \$100 bills and yellow ducks, both contained the phrase, "COLIN DIT IT!" on them. The Norfolk County District Attorney's Office investigation cleared Colin Albert from being considered a suspect in the death of John O'Keefe. Colin Albert has never been

charged with any crime related to the Commonwealth vs Read case.

- 102. On Wednesday, May 22, 2024, at approximately 8:30AM, a member of the Norfolk County District Attorney's Digital Forensics Division, Detective Barrett of the Stoughton Police Department, along with Detective Sergeant Lehan and Detective Taylor of the Canton Police Department went to 125 Lake Dr Stoughton, MA 02072, to execute search warrant # 2255SW0057 issued on Monday, May 20, 2024. The purpose of this search warrant was to conduct a download of the Infotainment System data from the black 2023 Toyota Tundra bearing Vehicle Identification Number (VIN) # 5FTMA5DB3PX067104.
- 103. An initial attempt was conducted on Thursday, May 16, 2024, at Canton Fence 1219 Washington St Stoughton, MA 02072 however technicians were unable to complete the download due to a hardware compatibility issue. After determining this, all members of the Stoughton Police Department, Canton Police Department, and Norfolk County District Attorney's Digital Forensics Division technicians. Upon a follow up conversation between technicians and BERLA support expert, a new method was provided, that would allow the download process to be completed.
- 104. While speaking with Detective Barrett, she informed us, that the Stoughton Police Department had been called to this residence the night prior. According to Detective Barrett, neighbor(s) had called in regards to the homeowner, Richard Schiffer Jr, allegedly shooting bottle rockets at ducks coming on to his property via the pond that abuts the rear of his residence.
- 105. Upon our arrival at 125 Lake Dr, I rang the doorbell and was greeted by a party known to me as Richard L. Schiffer Jr. Richard asked me if this was about the thing with the ducks. Not knowing what duck issue, he was referring to, I explained to Richard that I was here today with a search warrant to complete a download of the Infotainment System from his truck. I informed him that if he wanted to have a conversation, I would like to provide him his Miranda Rights. Richard declined and stated this is an issue people are pretty emotional about. Richard then gave me his key fob to conduct the Infotainment System download.
- 106. When the vehicle door was opened and the key fob was inside the vehicle the screen illuminated displayed the message, "Hi Richie." In the settings screen, it lists the Current Driver as Richie Schiffer. On the same screen, under the Saved Profiles portion it lists Richie Schiffer and displays "Primary Driver," under his name. There were no other names of drivers listed in the Saved Profile section for the vehicle. As previously noted in this investigation, he is the only one observed operating this vehicle.
- 107. The Norfolk County District Attorney's Digital Forensics Division technician was able to complete the download to a USB.
- 108. At approximately 9:00AM, the download was completed and I returned Richard his key fob. After returning him his key fob, all parties left 125 Lake Dr Stoughton, MA.
- 109. In a follow up conversation with the Norfolk County District Attorney's Digital Forensics Division, I was

informed the download was a success, the files were being processed, and I would be contacted when the entire process was completed.

- 110. On Thursday, July 11, 2024, (4th documented incident) I was made aware of a littering incident that occurred in the area of D & E Pizza and Subs.
- 111. As noted in Officer McDonald's report, this incident was identical to several other incidents that have occurred in the past. In previous incidents, counterfeit \$100 bills were littered in front of D & E Pizza and Subs. These incidents occurred on March 6, March 13, and April 6, 2024. As a result of the investigation into the April 6, 2024 incident, a suspect was identified. This suspect was later identified as Richard L. Schiffer Jr. of 125 Lake Dr Stoughton, MA 02072. In addition to the identification of Richard L. Schiffer Jr, his vehicle, a 2023 Toyota Tundra bearing MA COMM Reg: FNSGYZ was identified as the suspect vehicle used during the April 6, 2024 incident.
- 112. Officer McDonald's report, notes that a black Toyota Tundra pick-up truck was captured on video driving past D & E Pizza and Subs with bills being littered from the truck. This modus operandi appeared to be the same as Richard L Schiffer Jr including the use of a black Toyota Tundra pick-up truck.
- 113. During the investigation of a previous incident, it was later determined, he was the owner of a black 2023 Toyota Tundra bearing MA COMM Reg: FNSGYZ. A previously executed search warrant for the infotainment system of the vehicle, the dashboard touchscreen settings screen displayed, "Richie Schiffer," as the current driver, "Richie Schiffer," as the primary driver and, "Richie's iPhone," as a connected Bluetooth device. There were no other drivers or connected Bluetooth devices listed.
- 114. After being sent video surveillance footage by Chris Albert, I was able to download the footage to my desktop computer and begin reviewing the footage. A camera affixed to the front window of D & E Pizza and Subs, captured the following footage for Tuesday, July 11, 2024. *All times as noted below are approximate*.
- 115. 2:18:37PM black Toyota Tundra enters the frame from the left on Washington St heading towards the intersection of Bolivar St. I immediately took notice of the front chrome grill and the front vanity plate that I knew from a previous investigation to be a black novelty plate with a blue line through it containing a white silhouette of a Harley Davidson logo
- 116. 2:18:39PM as the black Toyota Tundra exits the right of the frame, several counterfeit bills are seen coming from the driver's side of the vehicle, indicating that they were thrown from the vehicle
- 117. I was also able to obtain video from the Chai Jewish Center located at 576 Washington St Canton, MA for Tuesday, July 11, 2024. The video provided, shows traffic travelling on Washington St, including the intersection of Washington St at Bolivar St. The video shows beyond the intersection including the area in front of D & E Pizza & Subs. *The time noted below is approximate*.

- 118. 2:18:40PM the same black Toyota Tundra (front chrome grill and the front black novelty plate with a blue line through it containing a white silhouette of a Harley Davidson logo) appears into frame travelling on Washington St towards the Bolivar St intersection, it proceeds straight through the intersection and continues travelling straight ahead towards the intersection of Washington St at Neponset St
- 119. A FLOCK traffic camera located at the intersection of Washington St at Neponset St captured a photo of the vehicle travelling past it at approximately 2:18:40PM. The distance from the intersection between Washington at Bolivar and Washington St at Neponset St is less than one fifth of a mile. The photo shows the rear of the vehicle clearly displaying, "TUNDRA," MA COMM REG: FNSGYZ, and the same Harley Davidson sticker with wings coming out of both sides affixed to the rear window.
- 120. A query of the Massachusetts Registry of Motor Vehicles shows that MA COMM Reg: FNSGYZ, is registered to Canton Fence Co Inc of 1219 Washington St Stoughton, MA 02072. This now more recent query showed it to be the exact same vehicle, further identified by the fact that the Vehicle Identification Number (VIN #) had not changed.
- 121. Given that the Vehicle Identification Number (VIN#) has not changed, it further shows that this is the exact same vehicle that during the execution of a search warrant the touchscreen display system showed, "Richie Schiffer," as the primary driver, no other driver profiles listed, and, "Richie's iPhone," as the only Bluetooth connected device to the vehicle.
- 122. As previously noted, Richard L Schiffer Jr is the President and Owner of Canton Fence Co Inc. located at 1219 Washington St and his residential address is 125 Lake Dr Stoughton, MA 02072. I have provided him a search warrant at both locations regarding his involvement with a previous incident, nearly identical to this one.
- 123. On March 6, 2024, approximately 20 counterfeit bills were recovered in the area of Washington St at Revere St intersection displayed "Justice for BPO John J. O'Keefe # 2490 Last watch 02/29/2022," on the front and "COLIN DID IT!" on the rear. This location is approximately 100 yards from D & E Pizza & Subs. As previously noted, this date is an obvious error. John O'Keefe's date of death was 01/29/2022 (January 29, 2022) and the date of 02/29/2022 (February 29, 2022) did not exist, as 2022 was not a leap year. All counterfeit bills recovered after March 6, 2024, have had the "2" in the month portion of the incorrect date 02/29/2022, removed. Of all incidents where bills were recovered, this is the only incident where the incorrect date is fully displayed.
- 124. Upon examining the counterfeit \$100 bills, recovered on Tuesday, July 11, 2024, I noticed them to be identical to the counterfeit \$100 bills recovered from previous incidents from March 13, 2024 and April 6, 2024. The "2" in the month portion had been removed displaying it as, "Justice for BPO John O'Keefe # 2490 Last Watch 0/29/2022." There is a gap between the "0" and the forward slash since the "2" had been removed. The counterfeit bills recovered on July 11, 2024 have the exact same serial number displayed on the top left-hand corner of the bill from previous incidents.
- 125. Once again, the "Justice for BPO John O'Keefe # 2490 Last Watch 0/29/2022," appears to be a blue ink

stamp that appears to hand stamped and not printed, as the direction of the phrase appears to be slightly askew and in different locations on each counterfeit bill. Regardless of accuracy of the date displayed, this has been a consistently exact identifier for each bill recovered.

- 126. Also, once again, the rear of the counterfeit bill displays the same phrase, "COLIN DID IT!" via a red ink stamp that has been seen on every bill recovered at each incident since March 6, 2024, regardless if the correct date was displayed on the front or not. The red ink, "COLIN DID IT!" stamp appears to be hand stamped and not printed, as the direction of this phrase also appears to be slightly askew and in different locations on each counterfeit bill. This exact identifier has been consistent on each of the counterfeit bills. The, "COLIN DID IT!" phrase displayed on the rear has never been altered.
- 127. All of the bills recovered during this fourth incident appear to be identical to the box with the partial stamp recovered during the trash pull conducted on April 10, 2024. The font and color displayed by the partially washed off stamp on the white box is the exact same that has been used during all other previous incidents in the area of D & E Pizza and Subs.
- 128. Everything about this fourth incident is nearly identical to all the previous incidents since March 6, 2024. The counterfeit bills littered during this incident are the same bills that have been used during each incident. These counterfeit bills recovered are the exact same bills that Richard L. Schiffer has made a Facebook post admitting to previously littering, stating he knew he was passing out propaganda via littering, he was solo during these incidents, and no one put him up to it. Included in this post was a copy of the search warrant I provided to him, in-hand on May 16, 2024.
- 129. The investigation into this fourth incident has once again shown that a black Toyota Tundra pick-up truck once again littered counterfeit \$100 bills outside of D & E Pizza and Subs located at 618 Washington St, Canton, MA 02021. These were the exact same bills used during previous incidents displaying "Justice for BPO John O'Keefe # 2490 Last Watch 0 /29/2022," on the front and "COLIN DID IT!" on the back.
- 130. It has further established that the black Toyota Tundra used on Tuesday, July 11, 2024, is the exact same vehicle used by Richard L Schiffer Jr during the previous incident on April 6, 2024. This was further established by the unique identifiers located on the front of the vehicle, specifically the chrome grill of the vehicle and a unique front black novelty license plate with a blue line through it containing a white silhouette of a Harley Davidson logo being captured on two separate video surveillance systems.
- 131. A FLOCK traffic camera also captured the rear of the vehicle travelling away from the direction of the littering of the counterfeit \$100 bills within seconds of the incident occurring. The image captured by the FLOCK traffic camera showing the rear of the vehicle, displayed, "TUNDRA," on the rear of the vehicle, a Harley Davidson sticker with wings protruding from both sides on the rear window of the vehicle, and the black Toyota Tundra bearing MA COMM Reg: FSNGYZ attached to the rear. This has been established as being the exact same vehicle not only by the unique physical features of the vehicle, but by the fact that a query of MA COMM Reg: FNSGYZ shows it as still being the same year, make, model, and having the same Vehicle

Identification Number (VIN) # 5FTMA5DB3PX067104 for the April 6, 2024 incident. Having same Vehicle Identification Number (VIN) # establishes the fact that this is the exact same vehicle, if a vehicle similar in appearance were to be registered, the Vehicle Identification Number (VIN) # would be different.

- 132. On Saturday, July 27, 2024, (5th documented incident) I was made aware of a littering incident that occurred in the area of D & E Pizza and Subs.
- 133. Previous incidents have involved littering of counterfeit \$100 bills with phrases such as "Justice for BPO John O'Keefe # 2490 Last Watch 02/29/2022" (some displaying the incorrect date including the "2" and others with the "2" removed) on the front and "COLIN DID IT" on the rear. Small yellow rubber ducks were also located during an incident on April 6, 2024 and all contained stickers on the bottom that stated, "COLIN DID IT!"
- 134. The phrase, "COLIN DID IT!" is a phrase used by members of the Free Karen Read movement to publicly accuse Colin Albert of murdering John O'Keefe. Colin Albert is a witness in the Commonwealth vs Read trial, he has testified before a federal grand jury, a Massachusetts grand jury, and has never been charged with a crime.
- 135. As noted in reports by Officers Pascarelli and Cavanagh from July 27, 2024, more than 30 yellow ducks were collected with a sticker on the bottom that contained the letters, "IYKYK." These letters are an acronym for the phrase, "If You Know You Know." A witness reported to Officer Cavanagh that they saw an older white male with white hair driving an older model dark colored convertible throwing the yellow rubber ducks out on Bolivar St. All yellow rubber ducks recovered had the, "IYKYK," sticker attached to the bottom.
- 136. This witness later reported to me that they saw the same party in the same vehicle throwing yellow rubber ducks out onto Lincolnshire Rd. This witness, who is known to Officer Cavanagh, the Commonwealth, and I is otherwise being withheld at this time. This witness is fearful of any retribution that may result due to them providing information to the Canton Police Department. Throughout the Commonwealth vs Read trial, there has been ongoing harassment of witnesses and investigators. Harassment of witnesses throughout the trial has led to several individuals being charged with misdemeanors and felonies.
- 137. I have been investigating these incidents for several months now and this a common trait among any witness who comes forth with information and/or evidence in regards to these incidents. Not only are these witnesses fearful of being retaliated against, harassed, intimidated, and doxed, they have expressed the same in regards to their family(s) and place(s) of employment.
- 138. The yellow rubber ducks with the, "IYKYK," stickers on the bottom were recovered on Saturday, July 27, 2024, at various locations throughout the Town of Canton. I took note of specific locations where ducks were located or later observed being littered via video surveillance footage.
- 139. Every incident prior to July 27, 2024, the area of D & E Pizza and Subs has been a targeted location. On

April 6, 2024 the other significant location was in the neighborhood of John O'Keefes residence prior to his death. This is currently the address where his elderly parents reside with two of their grandchildren (John's niece and nephew). Both of these minor children testified in the Commonwealth vs. Read trial. The next day, April 7, 2024, the same ducks were found in the neighborhood, including on the property where Michael Proctor resides. Michael Proctor is the lead investigator in the Commonwealth vs Read case and lives at his residence with his wife and two young children.

- 140. On July 27, 2024, several different locations were littered with propaganda. Two of the locations had a direct relation to the Albert family. One location was outside of D & E Pizza and Subs and another at the intersection of Washington St at Maple St. This is now the fifth incident where D & E Pizza and Subs has been the target location of littering propaganda.
- 141. The other location was the intersection of Washington St at Maple is the entranceway to his residence where he resides with his family, including his wife Julie Albert and son Colin Albert. In addition to Chris, both of them testified as witnesses in the Commonwealth vs Read trial.
- 142. As noted in Detective Theodore's report, Chris was asked to review any video surveillance footage that may have been captured by his cameras at D & E Pizza and Subs. I later spoke to Chris about obtaining the footage and he was able to provide with me several clips of video surveillance footage. These clips were later downloaded and viewed by me on my desktop computer at the Canton Police Department.
- 143. A camera affixed to the front window of D & E Pizza and Subs captured the following footage for July 27, 2024. All times as noted below are approximate.
- 144. 1:08:54PM a dark colored older model convertible can be seen travelling slowly on Washington St towards D & E Pizza and Subs, coming from the direction of Waterfall Bar & Grille located at 643 Washington St. As the vehicle continues to slowly travel forward, the driver who is the lone occupant of the vehicle, can be seen extending his arm above the windshield of the vehicle and is seen throwing items, out of the vehicle in the direction of Richard Lewis Formal Wear located at 626 Washington St (approximately 75 feet from D & E Pizza and Subs)
- 145. While reviewing this particular portion of video surveillance footage, I took note of how slow the vehicle appeared to be travelling, almost coming to a stop in front of Richard Lewis Formal Wear. This location is the same location where a witness from the Saturday, April 6, 2024 incident, reported seeing a black pick-up truck littering the counterfeit \$100 bills stating "Justice for BPO John O'Keefe # 2490 Last Watch 02/29/2022" on the front and "COLIN DID IT!" on the rear. In addition to the counterfeit bills, yellow rubber ducks with a sticker stating, "COLIN DID IT!" were also located in this area. This investigation has previously determined the black pick-up is owned by Richard L. Schiffer Jr and he is the only operator of the vehicle.
- 146. 1:09:07PM the same dark colored older model convertible continues travelling slowly and appears right in front of D & E Pizza and Subs. As the vehicle slowly passes by, the driver's right hand can be seen off the

steering wheel and several yellow ducks appear to come from the vehicle; as they are seen rolling across the ground towards D & E Pizza and Subs indicating they were thrown from the vehicle, the driver appears to be an older white male, with white hair, wearing a dark colored baseball hat, the vehicle continues to travel straight on Washington St

- 147. A FLOCK traffic camera located at the intersection of Washington St at Neponset St captured a photo of the vehicle travelling past it at approximately 1:10:34PM. The distance between from D & E Pizza and Subs is approximately one fifth of a mile. The photo shows the rear of the vehicle, a dark colored older model convertible, bearing MA Reg: PS679. The photo also shows an older white male, with grey/white hair, wearing a dark colored baseball hat.
- 148. A query of MA Reg: PS679 via the Massachusetts Registry of Motor Vehicles, lists the vehicle as a 1999 black Mercedes Benz SL assigned Vehicle Identification Number (VIN) # WDBFA68F2XF175746 and the vehicle is registered to Richard L. Schiffer Jr. of 125 Lake Dr Stoughton, MA 02072, date of birth March 20, 1959, MA OLN # S22877374. A query of 125 Lake Dr Stoughton, MA 02072 shows that Richard L. Schiffer Jr. is still the only licensed driver at that address.
- 149. I have previously had several interactions with Richard L. Schiffer Jr investigating him as a suspect in previous crimes. I know him to be an older white male, approximately 65 years of age with grey hair. This is similar to the description of him given by a witness, my observations of him in person, and my observations of him of the operating his vehicle via video surveillance footage.
- 150. This is now the fifth incident, that the same Richard L. Schiffer Jr. that has been identified as the perpetrator. Prior to this incident, he has been identified as the perpetrator on March 6, 2024, March 13, 2024, April 6, 2024, and July 11, 2024.
- 151. I later received information that several yellow rubber ducks had been located on the patio area of Elsie's Table located at 497 Washington St. Elsie's Table is owned by Renee Roberts. She is the sister-in-law of Kerry Roberts, who also testified in the Commonwealth vs Read trial.
- 152. I was able to obtain video surveillance footage from Elsie's Table which depicted various angles that captured the dark colored older model convertible being driven by an older white male party wearing a dark colored baseball hat. The display is off by one hour. The system display time had not been adjusted for daylight savings time, according to Elsie's Table Manager Eric Hanlon.
- 153. The camera affixed to the front exterior of Elsie's Table that captures the intersection of Washington St at Neponset St. At approximately 1:10:31PM (display time 12:10:31) the same dark colored older model convertible drives through the intersection coming from the direction of D & E Pizza and Subs. As the vehicle passes through the intersection, the video shows the same older white male wearing a dark baseball hat driving the vehicle.

- 154. Another camera affixed to the front exterior of Elsie's Table captures Washington St showing traffic travelling on Washington St, depending upon direction of travel, it shows vehicles entering or exiting the Washington St at Neponset St intersection. At approximately 1:10:34PM (display time 12:10:34) the same dark colored older model convertible drives through the intersection on Washington St heading towards the direction of Cobbs Corner being driven by the same older white male wearing a dark baseball hat driving the vehicle.
- 155. A camera affixed to the side of Elsie's Table shows traffic further down Washington St towards Cobbs Corner. At approximately 1:10:34PM (display time 12:10:34) the same dark colored older model convertible drives through the intersection on Washington St heading towards the direction of Cobbs Corner being driven by the same older white male wearing a dark baseball hat driving the vehicle. I believe this individual to be Richard L. Schiffer Jr.
- 156. Now having identified the preparator as Richard L. Schiffer Jr. and the vehicle registered to him, a 1999 black Mercedes Benz SL bearing MA Reg: PS679. I began reviewing video surveillance footage from cameras that capture Pine St and the intersection of Pine St at Bolivar St. *All times as noted below are approximate*.

Pine St Camera

157. 1:03:17PM – the suspect vehicle, older model dark colored convertible, is seen driving on Pine St towards the intersection of Pine St at Bolivar St

Pine St at Bolivar St Intersection Camera

- 158. 1:03:24PM the suspect vehicle continues on Pine St, proceeds through the intersection of Pine St at Bolivar St, failing to stop at the stop sign, it goes straight traveling towards Lincolnshire Rd. This is where several ducks with the, "IYKYK," stickers on the bottom were located and a witness observed the suspect, identified as Richard L. Schiffer Jr. littering the ducks from his vehicle.
- 159. Later I examined and took photographs of the ducks littered throughout the Town of Canton on July 27, 2024. The yellow rubber ducks appear to be the same yellow rubber ducks that were littered on April 6, 2024. The only notable difference between them was the sticker on the bottom had a black circle with the letters, "IYKYK," on the bottom.
- 160. Upon closer examination of the stickers, I observed them to be clear 1-inch stickers that appeared to be identical to the type of stickers that stated, "COLIN DID IT!" on the bottom of the yellow rubber ducks that were recovered on April 6, 2024.
- 161. As a result of a previous investigation, I knew these types of stickers can be ordered from makestickers.com. A previously executed search warrant to makestickers.com showed that 250 1-inch clear stickers with red font stating, "COLIN DID IT!" were previously ordered and delivered to Richard L. Schiffer Jr. of 125 Lake Dr Stoughton, MA 02072. Believing these, "IYKYK," stickers were also ordered from

makestickers.com, I contacted Adam Feil of makestickers.com. During my conversation with Adam, he stated that additional orders had been placed since April 6, 2024, but any new information in regards to this account would require another search warrant. I will be applying for a search warrant to further determine if these stickers were ordered by Richard L. Schiffer Jr. and shipped to his residence or business (Canton Fence Co. Inc.)

- 162. Several locations of the yellow rubber ducks have significance in regards to the Commonwealth vs Read trial. In previous incidents, Richard L. Schiffer Jr. would target area in the immediate vicinity D &E Pizza and Subs. This time yellow rubber ducks were located or observed in the following locations, the intersection of Washington St at Maple St, D &E Pizza and Subs, Waterfall Bar & Grille, Richard Lewis Formal Wear, Elsie's Table.
- 163. The intersection of Washington St at Maple St is the entrance where members of the Albert family reside. Three of them testified in the Commonwealth vs Read trial. D & E Pizza and Subs is the business owned and operated by Chris Albert. This location has been the target of Richard L. Schiffer Jr's actions. Waterfall Bar & Grille is the place of employment of another witness who testified in the Commonwealth vs Read trial. Richard Lewis Formal Wear is the location where a witness observed seeing counterfeit \$100 bills being thrown from his vehicle in a previous incident that resulted in criminal charges against him. Elsie's Table is the restaurant owned by Renee Roberts, she is the sister-in-law of Kerry Roberts. Kerry Roberts is also another witness who testified in the Commonwealth vs Read trial.
- 164. The fact that Richard L. Schiffer Jr's littering incident locations are becoming more specific to the residences and workplaces of witnesses in the Commonwealth vs Read trial, show that his behavior is escalating and being more specifically directed towards witnesses who testified during the trial.
- 165. On Saturday, August 17, 2024, (6th documented incident) at approximately 11:00AM, while working as the on-duty detective, I was travelling on Washington St. I was travelling northbound towards the Canton Police Department after clearing a previous call for service. As I travelled on Washington St, I viewed ahead of me a black Toyota Tundra travelling towards my direction.
- 166. I took notice of this vehicle, as it was not just a black Toyota Tundra, but it was a black Toyota Tundra I am familiar with through the course of several previous investigations. More specifically, this Toyota Tundra has a silver colored front grilled, with front license plate that is a "thin blue line" plate bearing a white silhouette of a Harley Davidson logo with the letters FLTRXS inside of it. I also know this unique vehicle to bear a rear license plate of MA COMM: FNSGYZ.
- 167. This vehicle is registered to Canton Fence Co Inc. 1219 Washington St Stoughton, MA 02072. Canton Fence Co Inc. is owned and operated by Richard L. Schiffer Jr. whose residential address is 125 Lake Dr Stoughton, MA 02072. I have had previous interactions with him in person as he is the subject of this investigation involving previous littering incidents. I have also served him with search warrants at both locations, his residence and Canton Fence Co Inc. (the business he owns and operates). Later on the same day, during surveillance of this vehicle being operated by Richard Schiffer, I observed it bearing MA COMM License

Plate: FNSGYZ. Further inquiry into this license plate shows the same Vehicle Identification Number (VIN #) 5TFMA5DB3PX067104, as previous incidents. Therefore, he is still committing these acts of littering propaganda designed to harass witnesses in the Commonwealth vs Read trial using the exact same vehicle.

- 168. After the vehicle passed me heading the opposite direction, I turned my car around, reversing direction to observe and follow the vehicle. At the time of my initial observation, the vehicle was headed towards an area where Richard L. Schiffer is known to litter counterfeit \$100 bills and yellow rubber ducks with various phrases on them. As I attempted to catch up to the vehicle, I noticed it parked in the area in front of 626 Washington St (Richard Lewis Formal Wear & Kevin Michaels Men's Fine Clothing). This area is in the immediate vicinity of D &E Pizza and Subs. This location is also the location from previous incidents where witnesses have seen him littering counterfeit \$100 bills.
- Toyota Tundra. I maintained a clear and unobstructed view of the vehicle from my vantage point the entire time. From my vantage point, I was able to observe the vehicle and areas in front of and behind the vehicle. As I was observing the vehicle, I watched the driver, an older white male, exit from the vehicle. I immediately recognized this party from my previous interactions with him as Richard L. Schiffer Jr. I then observed Richard L. Schiffer Jr enter 630 Washington St (The Stylists at 630).
- 170. After he exited the business, I observed him look around, open the rear passenger door, reach into his vehicle appearing to remove an item(s). I took notice of the fact that the location he appeared to remove an item(s) from the vehicle was the same area I previously located 37 yellow ducks with the sticker, "COLIN DID IT!" attached to them. After appearing to remove the item(s) from the vehicle, I observed him go to the flower box outside the business and place an item in the flowers.
- 171. Afterwards I watched him walk southbound on the sidewalk towards the direction of D &E Pizza and Subs, and appear to enter Richard Lewis Formal Wear & Kevin Michaels Men's Fine Clothing at 626 Washington St. Prior to entering, he appeared to place an item on the ground level window sill outside the front door of the business.
- Washington St and outside of 626 Washington St for any items that may have been placed there. This off-duty officer checked both areas and located the same yellow rubber ducks with a sticker on the bottom with the acronym, "IYKYK," (If You Know You Know). These were the exact same ducks previously recovered on April 6, 2024, May 16, 2024, and July 27, 2024 with the only different being the phrasing on the sticker. The stickers attached containing the acronym, "IYKYK," located by the off-duty officer were the exact same ones recovered by Canton Police Officers on July 27, 2024. I later located one of the ducks from the flower box outside 630 Washington St and took a photo of one of the ducks containing the acronym, "IYKYK."
- 173. Upon comparing the ducks with the, "IYKYK," stickers recovered on July 27, 2024 and ducks placed in the flower box of 630 Washington St, I took note of the fact they appeared to be similar as the, "COLIN DID IT!"

stickers previously recovered on April 6, 2024. They were both clear and were approximately 1-inch in diameter.

- 174. A previously executed search warrant determined that the, "COLIN DID IT!" stickers were in fact 1-inch clear circle stickers ordered by Rich Schiffer on March 31, 2024 from makestickers.com and delivered to his home address at 125 Lake Dr Stoughton, MA 02072 by FedEx on Thursday, April 4, 2024. This package also had his cell phone number of 617-799-7514 printed on the outside of the package.
- 175. I had previously spoke to Adam Feil at makestickers.com and he stated that more orders had been placed by Rich Schiffer AKA Richard L. Schiffer Jr since April 6, 2024, however any additional information would require a search warrant.
- 176. On Friday, August 30, 2024, I applied for and was granted Search Warrant # 2255SW0086 commanding makestickers.com to furnish me additional information in regards to orders sent to Richard Schiffer 125 Lake Dr Stoughton, MA 02072.
- 177. On Tuesday, September 3, 2024, I sent an electronic copy of the search warrant via email to Adam Feil of makerstickers.com. Later on, the same day, I received a PDF file from Adam Feil.
- 178. The PDF copy of Order # 16751002 was for an order of 250, 1" clear circle roll labels with black writing that stated, "IYKYK." The design image proof displayed in the PDF file is the exact same black colored font containing, "IYKYK," that had been observed attached to the yellow ducks on July 27, 2024 and August 17, 2024.

183. The shipment was sent to Richard Schiffer 125 Lake Dr 1219 Washington St Stoughton, MA 02072-3851 United States

- 184. Delivered via UPS on Thursday, July 25, 2024.
- 185. All of the above noted information returned via a search warrant is nearly identical to that of the information returned via Search Warrant # 2455SW0055.
- 186. The customer information such as the name, address, and phone number for the billing information are the same as the information previously returned. The location the shipment was sent to is also contains the same information as previously returned. The addition of 1219 Washington St Stoughton, MA 02072 in this return, is the address of Canton Fence Co Inc. Richard Schiffer is the President and Owner of Canton Fence Co Inc. Orders placed in April and July of 2024 were both paid for using a Mastercard credit card and the IP address used to conduct both transactions, are both the same.
- 187. This was now the second time a search warrant had been executed showing that Richard L. Schiffer did in fact order stickers from makestickers.com and had them shipped from the state of Illinois. The stickers are the same type of stickers located on the yellow ducks throughout the Town of Canton.
- 188. On Saturday, September 7, 2024, (7th documented incident) Sgt Brady of the Canton Police Department was dispatched to the address of John O'Keefe's former residence for another littering incident involving yellow ducks. Given that there were no other locations where the same yellow ducks were located, it appears as though this was a specific location targeted by perpetrator.
- 189. As previously noted, this is the house where John O'Keefe lived prior to his death. This is currently the address where his elderly parents reside with two of their grandchildren (John's niece and nephew). Both of these minor children testified in the Commonwealth vs. Read trial.
- 190. While on scene, it was reported to Sgt Brady that several ducks with the, "IYKYK," stickers were located on this same property days prior. These are the same ducks with the same, "IYKYK," sticker that have been recovered at specific locations throughout the Town of Canton, relevant to the Commonwealth vs Read trial.
- 191. These locations include the residences of witnesses and places of employment for witnesses, that gave testimony during the trial. These are the exact same ducks with the same stickers, I, Detective Taylor have witnessed Richard L. Schiffer remove from his vehicle and litter in the vicinity of C.F. McCarthy's and D & E Pizza and Subs.

- 192. A check of cameras at John O'Keefe's former residence and surrounding areas did not yield any footage showing the ducks being littered from a person or a vehicle. The exact address of John O'Keefe's residence is known to the Commonwealth and otherwise being withheld at this time to prevent future incidents at the address.
- 193. On Saturday, September 14, 2024, a group of people held a protest out the Canton Police Department located at 1492 Washington St. The protest was filmed by several protestors including several content creators.
- 194. One of the content creators is named Mike Crawford, who runs a YouTube channel called The Young Jurks. Mike was "live streaming" the protest via YouTube and Facebook while it was ongoing. (Live streaming is when a person records a video while it is being broadcasted live over the internet, not playing back a recorded video.) Typically, upon completion of the live stream, both of these platforms will save the video, including audio, to be viewed and heard later.
- 195. While he was live streaming, at approximately 52:00 into the live stream, Mike engages with an older white male party wearing a red MAGA KING hat, sunglasses, a dark colored tee shirt, and jeans at the protest. I immediately recognized this party as Richard L. Schiffer Jr.
- 196. Their interaction begins with Richard Schiffer handing a yellow rubber duck to Mike Crawford. On the bottom of the duck is the same, "IYKYK," sticker that has been most recently located littered on the property of John O'Keefe's residence prior to his death. Mike states that he has approximately 50 of them and sees them everywhere he goes, including the north shore. Rich asks him if he has "the red one, with the COLIN DID IT! on it"
- 197. Mike displaying the duck for the camera states, "That looks like something I could get arrested for in Canton."
- 198. Rich states, "Yeah right, well they went through my truck already, so they didn't find shit."
- 199. Mike asks Rich, "Are you the guy?"
- 200. Rich replies, "Yeah, I'm the guy. It's just a joke, Tully already came to my house, my shop, my business. Tully, Lehan and another Stoughton cop. Went through my truck, my system, my information system in my Toyota to see where I drove in the month of March. So, I started the duck campaign and the money campaign in February. So, I got caught on Proctor's ring cam and a bunch of other people, I don't care because I'm fighting the fight. So anyways, they went through my thing on a Thursday, Tuesday, the following Tuesday they came to my house I wake up in the morning at my house going through it again, the same thing same warrant two warrants and you know what they didn't find shit, they don't find nothing and you know what and I got the arrest warrant, I can email it to you."
- 201. The police officers he incorrectly refers to as Tully (Massachusetts State Police Lieutenant Brian Tully) as

coming to his residence and shop, is actually me, Detective Taylor, of the Canton Police Department.

- 202. Mike asks, "Did they arrest you?"
- 203. Rich replies, "Not arrest warrants, but the charges that they were going to charge with me with the police report, I'll send that to you."
- 204. Rich continues ranting on about Chief Rafferty, the ducks, and "Rita's lawn," "because people were asking."
- 205. Rich continues, "I am not hiding from nothing. I started this [while holding up a duck] COLIN DID IT! ones and I started the ones with this [while holding up a duck with the IYKYK sticker attached to it]. It's a trigger word, you know what I mean."
- 206. A Feeney Bros Utility Services dump truck drives by honking its horn and Rich can be seen throwing a duck at the truck and it lands in the back of the dump truck. Rich turns, looks back at the camera and says, "It went in!"
- 207. Mike asks, "So when they came to you, did they threaten you with certain charges?"
- 208. Rich replies, "They wanted to get me on intimidation, Mike, honestly what I think they're trying to do is connect me to Turtleboy. So they couldn't. So this is me, myself, and I here Mike. I've got nobody involved in this, I did this on my own, smoking a joint at night, thinking what more can I do to fucking help, so that was it and these are my signs I made up and I sat with the ducks and it's been hilarious ever since and I can't believe how it's grown and I've sent them to Sean, I've sent them to Dylan, I've sent them to everybody."
- 209. Mike says, "They're on the Northshore, I'll tell you, I see them everywhere."
- 210. Rich states, "But the secret is it's got to have the sticker because the stickers are the original ones, these are the original ducks. Like I said, it was an idea back in November but the in February I started it and uh they just don't like the message, the bottom line is they just don't like the message."
- 211. Mike and Rich converse back and forth about how they both believe they were targeted as a way get information about Turtleboy AKA Aiden Kearney and tell stories about him. They state Tully tried to send people to them to get them to tell stories about Aiden. Rich goes on to state that the purpose of the search warrant for his truck was an attempt to show him driving to where Aiden Kearney lives, and meeting with him at various locations. Aiden Kearney AKA Turtleboy has never been a subject of this investigation. No member of the Canton Police Department, including myself, has ever contacted Aiden Kearney in regards to any of the littering incidents since March 2024.
- 212. Rich states, "The charges were going to be anything from witness intimidation right, down to littering. I

didn't get charged with any of them and if you want to fucking litter right, give the fucking fine and let me fucking pay for it."

- 213. Rich continues, "... I've been here for 65 years of my life, I own a fence company, it's called Canton Fence, okay, I'm the man, I know every fucking asshole everybody in that building right there..." while pointing at the Canton Police Department.
- 214. Mike and Rich continue to converse back and forth about the Town of Canton, Canton Police Department, and the night of John O'Keefe's death. Mike at one point asks Rich if he has a lawyer for this matter.
- 215. Rich and Mike continue talking back and forth with Rich explaining to Mike he knows the truth and has had to correct Tom Derosier about what he believes is the truth, claiming he knows a lot of things, and so does Peter (referring to retired Canton Police Sgt Peter Murphy). He goes on to state that he saw Deputy Chief Tom Keleher working a detail with Kevin Albert, and Rich states he threw more ducks out of his vehicle on to the other side of the road in an area they were working a paid police detail.
- 216. Tom Derosier is a known vocal member of the Free Karen Read movement that has had several interactions with the Canton Police Department. This investigation has shown him to be an active participant in Richard's duck movement. He posts the ducks on social media, live streams and/or videos himself with the ducks, and hands them out to people at various standouts.
- 217. Referring back to his previous police interactions, Rich states the following,
- 220. "But nothing came of it, I got no charges, as of yet, uh I don't see anything coming down the line, and you know what I'd be happy to tell the judge that."
- 221. Over the course of approximately the last six months this investigation has established that, Richard L. Schiffer Jr is the lone perpetrator committing a pattern of behavior through a series of events that have violated several Massachusetts General Laws. Not only has Richard L. Schiffer violated several Massachusetts General Laws, he has on more than one occasion publicly confessed to his crimes. His confessions of his crimes have come via his own admission to me in person, a Facebook social media post authored by him, and a live streamed video interview at the Canton Police Department.
- 222. Prior to March 2024, Richard has never had any involvement with the Commonwealth vs Read trial. He is a member of society that followed the case through pretrial hearings, social media posts, and other forms of media coverage. He has never been called as a witness in the matter at any point nor does he have any known personal connections to any person involved with the case. He is a participant in the Free Karen Read movement, that has inserted himself into the Commonwealth vs Read trial, by harassing witness throughout the trial.
- 223. On or about January 19, 2024 during a pretrial hearing, Karen Read's attorney, Alan Jackson made an

argument on behalf of his client. As part of his argument, he stated the following expression,

"If it walks like a duck, talks like a duck, it's a duck."

- 224. Attorney Jackson used this expression during one of his arguments during a pretrial hearing of the Commonwealth vs Read trial towards opposing counsel's argument.
- 225. Richard later took the phrase used by Attorney Jackson while the Commonwealth vs Read matter was being adjudicated, and used it to insert himself into the matter and began to commit several crimes as further in this investigation through the use of the yellow rubber ducks and counterfeit \$100 bills.
- 226. Before and after the statements made by Attorney Alan Jackson in January 2024, Richard Schiffer posted in various Facebook groups and sharing/posting statements regarding the lead investigator in Commonwealth vs Read trial, Michael Proctor, members of the Albert family, and others who have been called as witnesses in the trial.
- 227. After making these statements made via social media platforms, Richard then began a pattern of escalating behaviors directed at testifying witnesses in the Commonwealth vs Read trial a total of 7 times. 4 of the 7 the incidents included littering yellow rubber ducks with either, "COLIN DID IT!" or "IYKYK," stickers attached to them.
- 228. On the following dates, April 6, 2024, July 27, 2024, August 17, 2024, and on or about September 7, 2024, Richard L. Schiffer Jr, by his own admissions, littered these yellow rubber ducks at these locations. All of these locations, as further described below, are significant and in direct relation to the Commonwealth vs Read trial.
- 229. On the property (containing the residence) of Michael Proctor who was the lead investigator in the case. He lives at this residence with his wife and two small children who are not involved with the Commonwealth vs Read trial.
- 230. On the following roads, Burke Dr, Casey St, and Fencourt Rd. These streets are part of the neighborhood that consists of 1 Meadows Ave. Ducks were located in the area of 15 Casey St. This location is where Casey St intersects with Meadows Ave. This location is less than 200 yards from John O'Keefe's residence prior to his death.
- 231. On the property of John O'Keefe's residence prior to his death. This address is currently the residence where John O'Keefe's elderly parents live with their minor grandchildren. These are the same minor children John O'Keefe adopted prior to his death. Both of these minor children even testified in the Commonwealth vs Read trial.
- 232. In the areas of Chris Albert's former residence on Meadows Ave and in the area of Chris Albert's current residence on Maple St. Chris lived/lives at these residences with his wife Julie and their children, including

Colin Albert, who Richard Schiffer has publicly accused of committing murder on more than one occasion. Colin Albert was a minor at the time of John O'Keefe's death and has never been charged with a crime related to John O'Keefe's death. Chris Albert, Colin Albert, and Julie Albert testified during the Commonwealth vs Read trial.

- 233. D & E Pizza and Subs located at 618 Washington St. This is a family business owned and operated by Chris Albert. This location has been the most frequent target of Richard Schiffer's actions via littering ducks or counterfeit \$100 bills dating back to early March of 2024.
- 234. The Waterfall Bar and Grill where John O'Keefe, Karen Read, and other witnesses were seen drinking prior to John O'Keefe's death. An employee of this establishment later testified in the Commonwealth vs Read trial.
- 235. Elsie's Table located at 497 Washington St. Elsie's Table is owned by Renee Roberts. She is the sister-in-law of Kerry Roberts, who also testified in the Commonwealth vs Read trial.
- 236. The Stylists at 630 located at 630 Washington St. Where I have personally witnessed Richard Schiffer litter these ducks in the flower boxes and immediate area outside of the salon. This location is in close proximity to D & E Pizza and Subs at 618 Washington St.
- 237. Richard Lewis Formal Wear & Kevin Michaels Men's Fine Clothing located at 626 Washington St. This location is also within close proximity of D & E Pizza and Subs. During several of his littering incidents, witnesses have been in or in the immediate are of the store on more than one occasion.
- 238. C.F. McCarthy's located at 614 Washington St. This is the business next door to D & E Pizza and Subs separated only a by a wall. This is one of the locations where John O'Keefe, Karen Read, and other witnesses were seen drinking prior to John O'Keefe's death. This business is in such close proximity to D & E Pizza and Subs, the littering incidents have occurred within the immediate vicinity of this establishment as well.
- 239. Richard utilized these yellow rubber ducks, in summation of his own words, spread propaganda/litter throughout the Town of Canton at the previously described locations.
- 240. His own self-admitted campaign of spreading propaganda has not only led to harassment of witnesses in the Town of Canton, but also in the Town of Easton. Caitlin Albert (daughter of Brian Albert, niece of Chris Albert) and her fiancé Tristan Morris have also located these ducks with "COLIN DID IT!" stickers littered on their property.
- 241. His own admission (via Facebook in May 2024) including a picture of the search warrant I provided him, establishes that he was aware that the information being put forth by him was designed to intentionally mislead others in an attempt to promote false information in an attempt to further harass witnesses in the Commonwealth vs Read trial, including members of the Albert family. Additionally, the Facebook post showed that he was well

aware he was the subject of a criminal investigation, and continued his reckless conduct of harassing witnesses, on at least 4 more occasions.

242. He later further admitted in a YouTube live video, admits that this spreading of propaganda via littering has grown into a movement, similar to that of the Free Karen Read movement. The interviewer on the video, Mike Crawford says he has 50 of them (referring to the ducks, and he sees them everywhere, including on the Northshore). He further credits himself for starting this movement by stating,

"So, I started the duck campaign and the money campaign in February."

"I am not hiding from nothing. I started this [while holding up a duck] COLIN DID IT! ones and I started the ones with this [while holding up a duck with the IYKYK sticker attached to it].

So, this is me, myself, and I here Mike. I've got nobody involved in this, I did this on my own, smoking a joint at night, thinking what more can I do to fucking help, so that was it and these are my signs [the sign has a picture of Colin Albert, with a yellow duck on him] I made up and I sat with the ducks and it's been hilarious ever since and I can't believe how it's grown and I've sent them to Sean, I've sent them to Dylan, I've sent them to everybody."

- 243. Sean is Sean McDonough a former Canton resident and retired DEA Agent living in the state of Florida. He also runs a YouTube page named, "Going Through the Motions," that has approximately 34,000 subscribers. He is a vocal member of the Free Karen Read movement.
- 244. On July 11, 2024, Sean McDonough broadcasted a live YouTube video (that has amassed approximately 55,000 views) where he says he recently spoke to a party via phone call whom he refers to as the, "King of the Ducks, The King of the \$100 bills," that told him he has ordered 5,000 ducks being delivered to him. I know through this investigation, the person he is referring to is, Richard L. Schiffer Jr. This same day, was the fourth time Richard littered propaganda via the counterfeit \$100 bills.
- 245. This movement of spreading propaganda via littering then publicly admitting to it via social media and YouTube videos that have amassed approximately 70,000 views total, has encouraged people to go to D & E Pizza and Subs at 618 Washington St and harass employees of the restaurant and members of the Albert family.
- 246. As noted in *Comm v. Johnson*, 470 Mass. 300 (2014) harassment can be accomplished through other people. (In summary, fakes ads, containing false information were made, causing people to constantly call the victim's residence and causing groups of people to show up at the victim's residence.) Richard's littering of propaganda (by his own admission) has caused people relying on false information to go to D & E Pizza and Subs to harass employees, members of the Albert family, and leave ducks with various messages just outside the restaurant. This includes people going to D & E Pizza and Subs and areas in the immediate vicinity littering ducks and wearing large duck costumes.

- 247. Several of these incidents have been responded to by the Canton Police Department resulting in criminal charges being filed. Additionally, the Massachusetts State Police has also responded and filed criminal charges against several individuals, including witness intimidation for their actions carried out at D & E Pizza and Subs.
- 248. On the following dates, March 6, 2024, March 13, 2024, April 6, 2024, and July 11, 2024 Richard littered counterfeit \$100 bills with various forms of "Justice for BPO John O'Keefe #2490 Last Watch 02/29/2022" stamped on the front and "COLIN DID IT!" on the back.
- 249. Each time he littered the counterfeit \$100 bills, he did so in the Canton Center area, one of the more highly concentrated areas of foot and vehicle traffic in the Town of Canton. D & E Pizza and Subs was located in the vicinity of each incident.
- 250. By his own admissions, spreading propaganda by littering the bills stamped with the phrase, "COLIN DID IT!" and yellow ducks with the, "COLIN DID IT!" he knew he was falsely accusing Colin Albert of committing murder.
- 251. Colin Albert was a minor at the time of John O'Keefe's death and has never been charged with a crime regarding this matter. Richard publicly accusing Colin Albert of committing murder via littering propaganda has caused Colin Albert and his father Chris Albert substantial emotional distress.
- 252. In addition to utilizing Facebook to admit to his crimes, Richard has been consistent with making Facebook posts on days he self admittedly littered propaganda.
- 253. March 6, 2024, made an unknown Facebook post and littered the counterfeit \$100 bills in the Canton Center area.
- 254. March 13, 2024, made several Facebook posts and littered the counterfeit \$100 bills in the Canton Center area within close proximity to D &E Pizza and Subs.
- 255. April 6, 2024, he changed his profile to a memorial picture of John O'Keefe. On this day he littered the Town of Canton with yellow rubber ducks and counterfeit \$100 bills in Canton Center in close proximity of D & E Pizza and Subs.
- 256. July 11, 2024, made an unknown Facebook post, a post about corruption, and a post that stated, "*More crazy shit*." On this day, he littered counterfeit \$100 bills in the Canton Center area in close proximity of D & E Pizza and Subs.
- 257. No Facebook posts were located for July 27, 2024, August 17, 2024, and September 7, 2024. Preservation requests have since been sent to Meta (Facebook's parent company) more information may come forward pending the execution of a search warrant.

Washington St is public way that is maintained by the Town of Canton.

MGL Chapter 270 Sec. 16 – Littering, for the littering incident on April 6, 2024 where counterfeit \$100 bills were located littered in front of D & E Pizza and Subs located at 618 Washington St with, "Justice for BPO John O'Keefe #2490 Last Watch 0 /29/2022," stamped on the front and "COLIN DID IT!" stamped on the rear. MGL Chapter 270 Sec. 16 – Littering, for the littering incident on July 11, 2024 where counterfeit \$100 bills were located littered in front of D & E Pizza and Subs located at 618 Washington St with, "Justice for BPO John O'Keefe #2490 Last Watch 0 /29/2022," stamped on the front and "COLIN DID IT!" stamped on the rear. Washington St is a public way that is maintained by the Town of Canton.

MGL Chapter 270 Sec. 16 – Littering, for the littering incident on July 27, 2024 where yellow ducks with an, "IYKYK," attached to the bottom were located littered in front of D & E Pizza and Subs located at 618 Washington St and throughout the Town of Canton at locations of significance to the Commonwealth vs Read trial. These specific locations include the residences' and places of employment for testifying witnesses during the trial. The locations the items were littered, are public ways that are maintained by the Town of Canton.

MGL Chapter 270 Sec. 16 – Littering, for the littering incident on August 17, 2024 where I personally observed Richard L. Schiffer Jr litter the same yellow rubber ducks with the same, "IYKYK," sticker on the bottom, outside of the other businesses in the area of D & E Pizza and Subs. The locations the items were littered, are sidewalks that are maintained by the Town of Canton.

MGL Chapter 265 Sec. 43A – Criminal Harassment, due to the facts established in this investigation beginning on March 6, 2024 that Richard L. Schiffer Jr. has self admittedly, by his own public proclamations, littered and spread propaganda at least 7 times at various locations throughout the Town of Canton. D & E Pizza and Subs located at 618 Washington St was his intended target 6 of the 7 times, further established by the fact it was the only location targeted nearly every time. This location is a family business owned by Chris Albert, who has been specifically targeted by Richard L. Schiffer's actions. Specifically, Richard Schiffer used the phrase

Richard Schiffer accomplished the harassment of Chris Albert through other people by causing to rely on this knowingly false information (as noted in Comm vs Johnson) to go to D & E Pizza and Subs to constantly harass employees, members of the Albert family, go there wearing large duck costumes, and leave ducks with various messages just outside the restaurant. Some of these harassing incidents, have led to misdemeanor and/or felony criminal charges being filed by the Canton Police Department and the Massachusetts State Police.
