I then walked away to continue to monitor the booking process. Rule 318D places the Duty Supervisor to find if probable cause exists to conduct a strip search. P.O. E2009-071, IAD2011-0583, IAD2012-0019, IAD2013-0145 and IAD2013-0192. On September 20, 2013, former Police Commissioner Edward Davis executed a Settlement Agreement in resolution of the above-referenced cases. Pursuant to the Settlement Agreement, Sgt. Kraft accepted a forty five (45) working day suspension with ten (10) working days to serve and the balance to remain in abeyance for one (1) year from the date of execution of the Agreement. On or about November 4, 2013, the Internal Affairs Division initiated IAD Case No. 2013-0461, alleging violations of Rules 320 §1B (Courts: Failure to submit Court Attendance Form) and §2 (Courts: Failure to appear when summonsed). The Bureau of Professional Standards sustained the abovereferenced charges in IAD Case No. 2013-0461 for conduct committed within the one (1) year abeyance time and after the execution of the above-referenced Settlement Agreement. As a result, pursuant to the Settlement Agreement, Sgt. Kraft will serve the balance of the forty five (45) working day suspension. The suspension will be served beginning on July 2, 2014.

At about 9:55PM the police stopped their car on Wood Ave., see CAD # 100561319, because they were not wearing seat belts. [REDACTED] stated that the occupants were not wearing seatbelts, but explained it was a dark out, raining and the car had tinted windows so the officers could not see in the car. [REDACTED] did not believe the officers had the right to conduct the stop in violation of Rule 102 Section 4 Judgment.

Sgt. Martin Kraft arrived on scene and identified himself by name to [REDACTED]. Sgt. Kraft verbally abused Mr. [REDACTED] by telling him to "Shut the fuck...You're a piece of shit." [REDACTED] said he was going to report the matter to Internal Affairs and Sgt. Kraft responded, "I don't give a fuck about Internal Affairs. When you get there, tell them I said fuck them" in front of the officers who were present, in violation of Rule 102 Section 9 Respectful Treatment.

Sgt. Kraft then ordered the occupant from the car. Sgt. Kraft and the other officers searched all the occupants of the car and then searched the vehicle for no reason in violation of Rule 102, Section 4 Judgment.

At the conclusion of the incident, they were allowed to drive away. They did not receive a verbal warning or citation for any violation.
