I met J.C. on Woll's beach he made a lot of small talk about Souther and told me he would let me know if my name came up in any investigations. I knew the game - he was trying to manipulate me and I doing the same regarding him. I explained it was uncomfortable for me to be sitting around in the company of law enforcement and give me awhile and I'd get back to him. Time passed + J.M. always nervous - worried J.C. would figure things out. I tried to calm him down he worried that the slightest hint would result in his being ^{put} on the box. He read every thing he could get on how to beat the box - books on how to lie - God he was one nervous devious guy - always scheming and most secretive.

So he comes up with a scheme to neutralize J.C. he tells me how he's going to ask J.C. to ask me for some money for him and for me to give it to him - this way if J.C. delivers, he's broke the F.E.D.S rules and I won't be quick to admit it. I go along with it, another time he says leave some \$ for him in wine box so J.C. knows a test to see J.C.'s reaction.

Maybe that Greek spy was feeding U.M. and he didn't want to lose him and of course he didn't want to lose Santa Claus. Regarding U.M. he was a good investment - he told me about John Callahan going to be in front of Grand Jury - I tried to warn Johnny Mc. to change location to no avail - will explain later.

One bad note with U.M. which he concealed from others was his pathological hatred for his wife - on the surface U.M. had a Norman Rockwell ~~family~~ marriage. After BULGER's initial escape from Boston to avoid prosecution, BULGER called MORRIS from London to confront him. MORRIS was working at the FBI Academy in Quantico, Virginia, at the time. BULGER told MORRIS "I should have put a bullet in your fucking head - you liar" and that he may still come back and kill MORRIS. MORRIS pleaded for forgiveness and then BULGER heard a thud and the phone dropping. BULGER said he found out MORRIS had had a heart attack while on the phone.

BULGER also recounted how he sometimes would tell associates a preposterous story with the admonition not to repeat that story to anyone and would never tell the same story to two people. If the story came back to BULGER he would know that it came from the only person to whom he had told that story and BULGER would then have that person "taken care of."

According to BULGER, both MORRIS and CONNOLLY applied to participate in a Master's program at Harvard University offered to FBI employees. CONNOLLY was selected to attend while MORRIS was not. This was the source of MORRIS's hatred for CONNOLLY.

At approximately 9:00 p.m. on 6/22/2011, FEDERAL BUREAU OF INVESTIGATION (FBI) Special Agent (SA) Olivier N. Farache and Acting Supervisory Special Agent (A/SSA) Maureen O'Connell were standing next to JAMES JOSEPH BULGER, aka Whitey Bulger, aka Charlie Gasko, date of birth 9/3/1929, social security account number _____ residence address of 1012 Third Street, Apt. #303, Santa Monica, California, while BULGER was being processed at the Metropolitan Detention Center located at 535 N. Alameda Street, Los Angeles, California. BULGER had been arrested earlier that evening in Santa Monica, California, along with his longtime companion CATHERINE ELIZABETH GREIG, date of birth 4/3/1951, social security account number not provided, residence address of 1012 Third Street, Apt. #303, Santa Monica, California. SA Farache informed BULGER that his processing would take a few more minutes, at which point BULGER voluntarily and spontaneously provided the following information:

BULGER stated that he was not in any rush to be processed as his life was basically over. All BULGER cared about from this point forward was helping clear the name of former FBI SA JOHN CONNOLLY. BULGER believed that CONNOLLY had been framed by former Boston Field Office Assistant Special Agent in Charge over the Organized Crime Task Force JOHN MORRIS. During CONNOLLY's criminal trial, MORRIS had admitted to taking several gifts as well as \$7000.00 from BULGER. However, BULGER had given much more than \$7000.00 to MORRIS and had been bribing him regularly for information. BULGER stated "you can add a couple of zeros to that \$7000.00 number." MORRIS used the money to keep a couple of mistresses on the side, even though BULGER thought MORRIS looked like "Barney Fife."

At some point during their relationship, MORRIS asked BULGER for help in getting rid of MORRIS's wife who MORRIS viewed as a burden. BULGER refused and told MORRIS to forget about it. Fearing that BULGER knew MORRIS had wanted to hurt his wife, MORRIS released false information to the press implying that BULGER had betrayed Italian organized crime figures in Boston by being an informant for the FBI. This information could have resulted in the Italian Mob killing BULGER, which, according to BULGER, was MORRIS's intent. The only thing that saved BULGER was his "sterling reputation" in the Boston underworld.

BULGER stated that sometime before Thanksgiving of 1994 he became aware that criminal indictments were coming down which might result in his arrest. BULGER stated that he had utilized the alias name THOMAS BAXTER and had obtained a New York driver's license in the BAXTER name many years prior. BULGER advised that THOMAS BAXTER was deceased. BULGER also stated that he had a birth certificate for THOMAS BAXTER. BULGER was questioned regarding dates and years of this activity. In response BULGER advised that he was not good in recalling dates and everything seemed to run together during the time after he was released from prison and while he was a fugitive. BULGER reiterated this fact on several occasions throughout the interview when he was unable to provide specific dates to include years when various activities occurred.

BULGER advised that he obtained the THOMAS BAXTER identification in order to have a good mailing address and identification in the event he needed to go on the run. BULGER continued that he bought several vehicles which were registered under the name THOMAS BAXTER. BULGER also advised that prior to fleeing the Boston area he had another false identification in the name of First Name Unknown (FNU) MCDONOUGH. BULGER stated that he did not like this identification and got rid of it at some point. BULGER was questioned further regarding the MCDONOUGH identification and refused to answer additional inquiries regarding MCDONOUGH or the identification. On a number of occasions throughout the interview when questioned regarding specific details BULGER would state that he did not wish to speak further regarding certain matters.

Upon further questioning regarding the THOMAS BAXTER identification BULGER began speaking of driving through the Roxbury section of Boston and other areas in vehicles which resembled police cars. BULGER advised that there were police scanners in these vehicles and he, sometimes accompanied by KEVIN WEEKS, would imply to individuals that they were police officers. BULGER explained that at one point he observed a black male who was in the South Boston area and he (BULGER) provided a ride home for this black male to the Roxbury section of Boston.

BULGER was again questioned as to his activities after Thanksgiving of 1994. BULGER advised that during this time, he caught wind that he was going to be indicted through contact with former FBI Supervisor JOHN MORRIS. BULGER stated that "MORRIS was my guy" and that a supervisor is a better source of information. BULGER advised that he initially left the area departing from South

Boston with TERESA STANLEY and drove throughout various areas of the United States. BULGER stated that he liked to go to museums, antique shops, and historical areas which he visited with STANLEY during these travels. BULGER advised that TERESA STANLEY liked to travel whereas CATHERINE GREIG was not fond of traveling because of her dogs. BULGER reiterated that they drove all over the United States. BULGER advised that he had established a mailing address in Seldon, New York, under the THOMAS BAXTER name and at this point felt comfortable with the THOMAS BAXTER identification.

BULGER advised that at some point during this trip with TERESA STANLEY he was driving with STANLEY back to Boston when he heard on the radio, possibly WBZ, that he and others, to include STEVE FLEMMI, had been indicted. BULGER stated that he had previously tried to persuade FLEMMI to leave Boston, but FLEMMI was trying to stay in Boston in order to assist his sons who had opened a business. BULGER advised that he listened to WBZ radio when returning to Boston inasmuch as WBZ could be picked up at the furthest point out from Boston.

BULGER stated that during his travels with TERESA STANLEY he knew that she wanted to return home. Therefore, after being made aware of the pending indictments and learning that he had been charged, he dropped TERESA STANLEY off in Boston and picked up CATHERINE GREIG.

Again during the above portion of the interview BULGER was questioned regarding specific time frames for these activities. BULGER again stated that he was not good with remembering dates and times and reiterated that since getting out of prison the time all seemed to run together.

BULGER stated that at some point he had two safety deposit boxes in New York City and also had a safety deposit box in Clearwater, Florida. BULGER advised he believed the amount in the safety deposit boxes in New York City may have totaled approximately \$35,000. BULGER was not willing to provide specific details regarding the safety deposit boxes in New York City. BULGER stated that during his travels he also went to the bank in Clearwater, Florida where he had a safety deposit box. BULGER

approached a female bank employee possibly with the last name BEEBE (phonetic). BULGER stated that he thought the teller was acting strange and believed she was stalling to call law enforcement upon his arrival at the bank. BULGER advised that he became confrontational with the woman instructing her to get the safety deposit box which he subsequently cleaned out. BULGER stated that he had also cleaned out the two New York City safety deposit boxes.

BULGER advised that he maintained safety deposit boxes and a couple of bank accounts in London, England, at the CHELTENHAM BANK. BULGER stated that he also had a safety deposit box in Paris, France, which was established prior to BULGER becoming a fugitive. BULGER stated that all safety deposit boxes were either in his true name or in the alias name of THOMAS BAXTER.

During the discussion of overseas bank accounts BULGER related an episode that occurred while he was in London. BULGER stated he was on a train when he was called a "yank" by an English citizen who was on the train. BULGER recalled that he responded by calling this individual "asshole" which resulted in an extensive fist fight on the train. BULGER stated that he had the THOMAS BAXTER identification with him at the time and was concerned he would be arrested and the BAXTER identification would be exposed. Additionally BULGER stated that he was bloody and feared arrest. BULGER advised he was not arrested and left the scene without further incident.

BULGER continued that he resented an individual named ALLEN THISTLE because THISTLE began going out with THERESA STANLEY after STANLEY returned to Boston. BULGER advised that THISTLE manipulated women. Additionally BULGER advised that at some point ALLEN THISTLE was causing problems at a bar and, upon being confronted, THISTLE said that he was somehow related to BULGER. BULGER advised that he was irritated that THISTLE said this and confronted him at some point. BULGER also stated that he had saved THISTLE's life. BULGER also spoke of meeting an individual named HENRY VARA through DONALD KILLEEN. BULGER advised that VARA owned a number of bars in Boston years ago.

At this point BULGER spontaneously began talking about his relationship with an individual named LOUIE LITIF who BULGER described as a bookmaker. BULGER stated that at some point LITIF shot a kid. BULGER continued that LITIF was a bookmaker who was acting like a "gangster" and BULGER told LITIF that he should stick to bookmaking and not try to be a gangster. BULGER stated that he

fined LOUIE LITIF \$10,000 in connection with LITIF's gangster-type activity. BULGER continued to relate a story that LITIF had killed an individual named BOBBY CONRAD and buried the body in Canada.

BULGER advised that he and CATHERINE GREIG, who on occasion he referred to as his wife, had made an agreement that if anyone in either one of their families died they would not return home to Boston for the funeral. BULGER did advise that he came back to Boston on several occasions during his fugitive status. BULGER stated that he returned to Boston on these occasions to "take care of unfinished business". BULGER refused to discuss what this business entailed. BULGER stated that he returned to the Boston area the last time approximately five or six years ago. BULGER advised that when he went to Boston on these occasions he always drove, and disguised himself extensively to include a wig, false facial hair and makeup. During these trips to Boston BULGER advised that he was also always "armed to the teeth". BULGER would not describe the specific vehicles he used to drive to Boston but did state that at one point he had a two door Honda Accord.

BULGER was questioned as to why he chose Santa Monica for his residence. BULGER stated that he had previously driven to California with THERESA STANLEY during which time they had stayed in Venice Beach. At one point BULGER considered obtaining an apartment or condominium in Venice Beach. BULGER stated that while in Venice Beach he became familiar with Santa Monica while driving in the area. BULGER stated he liked Santa Monica inasmuch as it was a cosmopolitan location with numerous transient and homeless people and vacationers. BULGER also advised that many Jewish people lived there and kept to themselves. BULGER stated that during the trip with TERESA STANLEY to the area he determined that Santa Monica would be a good location to go to if he became a fugitive. BULGER advised that during his initial trip to Venice Beach with TERESA STANLEY he traveled under the alias of THOMAS BAXTER.

BULGER advised that when he initially arrived in Santa Monica with CATHERINE GREIG he was still utilizing the name THOMAS BAXTER. BULGER advised again that he has problems keeping track of time but believes that he and GREIG arrived in Santa Monica sometime in 1995.

BULGER advised that, prior to arriving in Santa Monica with CATHERINE GREIG, he and GREIG were driving through Louisiana at which time they stopped at a rest stop/welcome center upon entering the state. BULGER stated that he went inside the rest area and observed a pamphlet that described Grand Isle, Louisiana. BULGER stated that the area looked interesting and isolated which caused himself and GREIG to travel to Grand Isle, Louisiana, where they lived for sometime prior to relocating to Santa Monica, California. BULGER stated that upon arriving in Grand Isle, he and CATHERINE GREIG, who BULGER again referred to as his "wife", struck up a conversation with a local family based on the family having dogs as pets and BULGER's and GREIG's affinity for dogs. BULGER stated that he liked these people who had the last name GAUTREAUX. BULGER continued that after getting to know the GAUTREAUXs he approached the family and requested that the family put property purchased by BULGER in their name. BULGER advised that he also bought property next door which was put in the GAUTREAUX's name. BULGER stated that over time he and GREIG became close to the GAUTREAUXs and assisted them in several ways including buying them appliances and giving the GAUTREAUX's \$10,000 in cash in exchange for their putting property purchased by BULGER in their name. BULGER stated that the children in the family also needed glasses which he purchased in addition to other items for the children. BULGER advised that he (BULGER) had a dog at one point while in Grand Isle. The dog became sick, after which GLENN GAUTREAUX put the dog down for BULGER. BULGER refused to provide additional information when questioned further regarding his time in Grand Isle, Louisiana, and his relationship with the GAUTREAUX family.

Upon questioning, BULGER stated that no one who knew BULGER's or GREIG's true identity, was aware of their location during their fugitive status. BULGER further explained that he would never tell anyone where he was because, upon questioning by law enforcement, he wanted individuals to be able to tell the truth when they stated that they did not know where he and GREIG were. BULGER also advised that he did not want to burden anyone who were close to himself or GREIG with knowledge of their whereabouts.

BULGER stated that at some point while in Grand Isle, Louisiana, he was tipped off that his THOMAS BAXTER identity had been discovered. BULGER stated that he and GREIG then left Grand Isle, Louisiana, and traveled again, eventually driving to Chicago in a vehicle that was registered under the name THOMAS BAXTER. BULGER stated that they abandoned the vehicle in a garage in Chicago and then took a train from Chicago to Los Angeles. Upon

arriving in Los Angeles, they stayed for a short time in a motel. BULGER advised that during the time in the motel he at one point heard helicopters above and commotion in the vicinity of the motel. At this point, BULGER believed that law enforcement was on scene to arrest him. BULGER stated the motel they were staying in was right across the street from the courthouse where legal proceedings were taking place for O.J. SIMPSON. BULGER figured out that the helicopters were not for him but were there to cover the SIMPSON story.

BULGER stated that after leaving the motel he and GREIG then went to the Santa Monica area where they obtained the apartment at 1012 Third Street, Number 303, in Santa Monica. BULGER stated that he and GREIG resided in this apartment from that time until they were recently arrested.

BULGER advised that prior to renting this apartment he had identified and targeted an individual in the area named CHARLES GASKO (phonetic) who was a street person with a drinking problem. BULGER advised that he scammed GASKO for a piece of identification which BULGER eventually received from GASKO. BULGER stated that he was then able to rent the apartment for himself and GREIG in Santa Monica under the name of CHARLES GASKO. BULGER described GASKO as an alcoholic who was at first uncooperative when BULGER approached him regarding obtaining identification. BULGER advised that GASKO did not have a driver's license but provided BULGER with some other piece of identification.

BULGER stated that he was aware of facial recognition technology and therefore did not want to obtain a California driver's license or any other identification with his actual photograph on it. BULGER stated that upon settling in Santa Monica he began looking for another individual besides GASKO from whom he could obtain alias identification. BULGER stated that during this process he observed a well dressed individual who looked just like him but appeared homeless. BULGER stated that he began conversing with this individual on occasion when he observed the individual along the oceanfront walk in Santa Monica. BULGER advised that he learned that this individual was from the lower east side of New York and had a similar background, including prior military service. BULGER advised that he planned to obtain some form of identification from this individual if possible. BULGER stated that at some point after a number of meetings and conversations with this individual he told this individual that he was in the United States from Canada with an expired visa and wanted to stay

in the United States. BULGER further advised that he told this individual that he needed a job and in order to obtain employment it was required that he have a driver's license. BULGER continued that he convinced this individual that he was illegally in the United States and asked this individual if he (BULGER) could have his driver's license. BULGER stated that the individual agreed after BULGER told him that he would give him \$1,000 for the license. BULGER advised that he was provided with a driver's license by this individual who BULGER identified as JAMES LAWLOR.

BULGER stated that, upon obtaining the California driver's license, he determined that the license was going to expire and he then paid LAWLOR \$300.00 to go get the driver's license renewed. Upon renewal, BULGER gave LAWLOR an additional \$2,500 for the license. BULGER stated that he maintained contact with LAWLOR and tried to get him to quit drinking. At some point BULGER obtained a rental unit for LAWLOR at a hotel and paid two weeks rent for LAWLOR. BULGER stated that he maintained contact with LAWLOR, attempted to sober him up, and subsequently paid his rent for years. BULGER continued that LAWLOR renewed the driver's license for BULGER on two or three occasions as it expired when BULGER was utilizing LAWLOR's identification. Additionally, LAWLOR provided BULGER with a birth certificate and "everything". BULGER stated that the apartment he paid rent on for LAWLOR was in West Los Angeles. BULGER stated that he paid rent for LAWLOR for approximately ten years and at some point obtained a vehicle which he registered with the Department of Motor Vehicles in LAWLOR's name. LAWLOR described this vehicle as a 2001 green Honda Accord. BULGER stated that he utilized this vehicle until LAWLOR died. When questioned regarding the time frame for LAWLOR's death all BULGER could recall was that it was "years ago". BULGER stated that he learned of LAWLOR's death which occurred in the apartment rented by BULGER after he had not heard from LAWLOR for some time. BULGER had CATHERINE GREIG call the rental office to check on LAWLOR at which time they learned that LAWLOR had died.

BULGER stated that he was close to JAMES LAWLOR in many ways besides just physical appearance. BULGER stated that LAWLOR had also been in the military and read a lot. BULGER continued that he attempted to get LAWLOR to quit drinking throughout their relationship however he was unsuccessful and LAWLOR eventually died from alcohol abuse. BULGER advised that he supported LAWLOR for approximately ten years.

BULGER stated that he (BULGER) made sure that LAWLOR never knew where BULGER actually lived. Additionally, BULGER was cautious and never went into LAWLOR's apartment building inasmuch as they looked too much alike and BULGER believed that the similarity might raise suspicion. BULGER stated that it was hard on him when LAWLOR died inasmuch as he had become close with LAWLOR and had supported him for ten years. BULGER became visibly emotional when talking about LAWLOR's death.

BULGER stated that upon LAWLOR's death he (BULGER) stopped driving the vehicle which was registered in LAWLOR's name. BULGER advised that LAWLOR was collecting benefits and he (BULGER) was concerned that his alias might be discovered if he continued to operate the vehicle registered in LAWLOR's name. Because of this concern, BULGER stated that upon learning of LAWLOR's death he (BULGER) wiped the vehicle down with alcohol and drove it close to LAWLOR's residence where he parked it leaving the keys and a liquor bottle inside the car. BULGER continued that he then "walked away" from the car and never drove again.

BULGER stated that at some point during his fugitive status he maintained a bank account at a BANK OF AMERICA near his residence in Santa Monica. The account was in JAMES LAWLOR's name. BULGER also stated that he may have had a checking account at this BANK OF AMERICA in LAWLOR's name. BULGER was questioned as to the location of any identification in LAWLOR's name to which BULGER replied that it would have been taken from BULGER's apartment during the search of his residence after BULGER was arrested.

BULGER advised that he loved going to Las Vegas and went on numerous occasions. BULGER stated that he played the slots and would often win money, giving one half of the winnings to LAWLOR. BULGER continued that CATHERINE GREIG did not like Las Vegas. BULGER advised that he won more money than he lost in Las Vegas.

BULGER stated that during his relationship with JAMES LAWLOR he continually attempted to get LAWLOR to quit drinking and exercise. BULGER stated that he was unsuccessful. BULGER advised that he believed he could continue to utilize JAMES LAWLOR's identification after he died but no longer wanted to drive the

vehicle registered to LAWLOR. BULGER stated that at some point during his relationship with LAWLOR, LAWLOR "flipped out" and told BULGER that he had a cousin in the FBI and "I know who you are". BULGER stated that this admission did not concern him because of the close relationship that he (BULGER) had established with LAWLOR.

BULGER stated that over the years he had obtained a number of false identifications in New York City. BULGER advised that it was easy to obtain identifications in New York City. Specifically BULGER mentioned obtaining identifications from "Chinamen" on the street in New York City. At some point, BULGER also stated that he had obtained false identification on 42nd Street in New York City from an Asian guy. BULGER added that he always drove when traveling to New York and never flew.

During interview BULGER advised that he was trying to provide helpful information and wanted consideration for CATHERINE GREIG. BULGER stated that GREIG was with him 24 hours a day for sixteen years. BULGER stated that he and GREIG actively helped stray cats and dogs during their stay in Santa Monica.

Upon questioning, BULGER stated he did obtain alias identification from "BARNEY" GROGAN while he was on the run. BULGER stated that the identification is no longer around and he was only providing this information because GROGAN is dead. BULGER continued that BARNEY GROGAN was known under the last name O'BRIEN while in prison. BULGER refused to provide any additional information regarding GROGAN or the identification he obtained from GROGAN.

BULGER stated that he facilitated and paid for the reburial of a friend and former ALCATRAZ inmate, Last Name CARNES. BULGER stated that he got to know CARNES' sister during the reburial process. BULGER advised that he never traveled back to ALCATRAZ while in fugitive status.

BULGER stated that he had hidden and subsequently picked up money from all over the country. Upon questioning, BULGER described the amount of money as "a lot" and stated that it was kept for him by individuals for whom he had done favors. BULGER stated that some of the money had been in Chicago. BULGER refused to provide additional information regarding this money except to say that he had hidden a lot of cash.

BULGER advised that while in Santa Monica he lived off the money he had hidden in the apartment. BULGER was questioned regarding how much money he had spent over the years. BULGER stated that "you (meaning law enforcement) should have gotten here fifteen years ago" implying that there was a lot more money present when he first arrived in Santa Monica. BULGER stated that he used cash to make purchases and lived off the money that was hidden in his apartment. BULGER continued that the money would have lasted a long time and explained some of this by stating that CATHERINE was not extravagant and they did not spend money on unneeded items.

BULGER stated that he had planned to be on the run long before he actually became a fugitive. BULGER stated that, while in prison, he had planned to get out and try for one year to get a good job, a woman, and go straight. BULGER continued that he attempted this but it did not work out. BULGER reiterated that he had planned to go on the run long before it actually occurred, and he came out of prison smarter and stronger than before he went in.

Without prompting, BULGER asked if during the search the investigators had noticed numerous candles. BULGER stated that he kept these candles in the bathroom because he had problems sleeping. BULGER blamed his sleeping issues on his participation in a LSD project while incarcerated in the Federal prison system. BULGER also advised the he had volunteered for a Pertussis project while in Federal prison. BULGER described several hallucinations which occurred after he had been given LSD while in prison. One example BULGER spoke of was the perception that skin was falling off individuals he believed he was observing while hallucinating. BULGER advised that at one point he volunteered to take the highest dose of LSD which had terrible results.

BULGER stated that he has a violent temper which may have resulted from his participation in the LSD project. BULGER continued that he always thought that his temper might get him in trouble resulting in his arrest. BULGER advised that CATHERINE helped him control himself and his temper. BULGER stated that he usually carried mace in Santa Monica, not a knife. BULGER stated that he had numerous firearms in his apartment and described

himself as a collector. BULGER continued that he bought these weapons at will and was not concerned with being arrested while purchasing the weapons. BULGER stated that he knows how to talk to people and was never worried about being arrested pursuant to a sting by law enforcement.

BULGER stated that he never went to Canada while a fugitive, and he had no criminal associates in Canada. BULGER advised that he did go to Mexico on several occasions while residing in California. BULGER would always quickly go in and out of Mexico via border cities traveling to Mexico only on foot. BULGER mentioned Tijuana as a specific location where he went into Mexico. BULGER stated that he went to Mexico to purchase medications. BULGER advised that he always planned ahead and would never wait until a medication was close to running out before he would make a trip for the purpose of obtaining medications. BULGER stated that he eventually began going to a doctor in the Santa Monica area and no longer had to travel to Mexico for medications. BULGER stated that his doctor in Santa Monica would be surprised when the doctor learned of BULGER's true identity and arrest.

BULGER was questioned regarding false identification provided to him in New York City after he became a fugitive. BULGER refused to discuss whether he was provided false identification in New York City by KEVIN WEEKS and/or PETER LEE. BULGER stated that he would not want to do anything to hurt PETER LEE and responded "what did they say". BULGER was also questioned as to whether CATHERINE GREIG had false identification to which BULGER directed interviewing Agents to "ask her".

BULGER stated that when he initially obtained the THOMAS BAXTER identification and address, it was an innocent step by step project just in case he got into some type of trouble. BULGER advised that he did not believe that KEVIN WEEKS would intentionally put the MATOS family in jeopardy and the introduction of BULGER by WEEKS to the MATOS family was initially just a favor so that BULGER would have a mailing address under the BAXTER alias. BULGER stated that he was not sure why WEEKS would put the MATOS family in that situation and suggested that WEEKS be asked why they were put in the position of allowing BULGER to use their address.

BULGER stated that at one point he did have two identical Grand Marquis vehicles while in fugitive status. BULGER stated that he bought these vehicles because of their speed and coaxial steering in case he needed to make an escape.

BULGER stated that, at some point during his travels, he did drive through the northwestern part of the United States, including Seattle, but didn't like it because it was too damp. BULGER advised that he did have to explain away his Boston accent on several occasions while a fugitive. BULGER advised that to do this he sometimes told people that it was a Chicago or Canadian accent.

BULGER advised that while in fugitive status he stayed away from libraries and was wise to computers. BULGER stated that during his years as a fugitive he was not armed when walking around or driving except when he went back to Boston on several occasions. BULGER stated that he "used my intellect not guns" to get out of jams while a fugitive. BULGER discussed one occasion during which he was assisting a couple in the desert who needed help changing a flat tire. BULGER advised that he had just recently gone on the run. A highway patrolman came on the scene. BULGER continued that he maintained his composure during the incident and changed the tire without being recognized or confronted by the officer. BULGER advised that he was invited to the couple's ranch after changing the tire, but declined. BULGER stated that he would not shoot a cop and he was never required to display identification to a law enforcement officer during his years on the run. Upon additional questioning regarding his fugitive activities, BULGER related that the brother of STIPPO RAKES had hidden out for five years in his (RAKES) mother's basement. BULGER continued that this individual was on the run because a young girl had died in a fire on STIPPO RAKES' brother's property. BULGER advised that the fire had been caused by "Jewish Lightning".

BULGER advised that he did discuss with CATHERINE GREIG what would happen if he (BULGER) should die. BULGER told GREIG that she had two options: either to remain in Santa Monica and lead the same life without him, or to go home.

BULGER advised that after he learned that his brother JACKIE BULGER had been put in jail, he (BULGER) was angry and became determined not to get caught or discovered in order to frustrate law enforcement. BULGER stated that one of his biggest worries besides his temper was that he would die in the apartment and be discovered. BULGER stated he therefore developed plans that if he should become sick he would consider two possibilities:

1. Go to the desert and die possibly with his body being deposited in an abandoned mine shaft with the intent that investigators never find his body.

2. Go to someone he (BULGER) could really trust and have that individual "blow the whistle" to law enforcement by turning in BULGER and collecting the two million reward. BULGER stated that he would have considered this if he had a terminal illness.

Without being questioned, BULGER stated that if he saw former FBI supervisor JOHN MORRIS he would have killed him. BULGER reiterated that he was mad at MORRIS and law enforcement authorities about his brother JACKIE being arrested and jailed. BULGER stated that MORRIS was "his partner" not JOHN CONNOLLY. BULGER advised that MORRIS had talked to him about an "FBI Hit Squad" which was available. BULGER stated that he did call JOHN MORRIS while MORRIS was at Quantico at which time BULGER initially identified himself as KEVIN WHITE. BULGER stated "MORRIS was my paid FBI informant" and he (BULGER) paid money to MORRIS on several occasions.

BULGER advised that while a fugitive he never had a passport or traveled outside the United States except for Mexico. BULGER stated that he was aware of the recent FBI publicity initiative focusing on CATHERINE GREIG and displaying her photographs. BULGER continued that he and GREIG discussed the situation and BULGER told CATHERINE "this is it". BULGER advised that investigators should have focused on CATHERINE long ago. BULGER advised that he told CATHERINE that they should stay indoors. BULGER continued that he and CATHERINE tried to remember the people that were close to them because two million dollars was a lot of money and \$100,000 was a lot too. BULGER also

stated that he purchased a camouflage cap to wear after he became aware of the new publicity. BULGER stated that he had "mellowed out" after fifteen years of posing as a legitimate person. BULGER continued that it was difficult to maintain his edge and continue thinking like a criminal after all these years. BULGER stated that this is part of the reason he came down to the garage area without becoming suspicious when he was arrested.

Upon landing BULGER was re-examined by Medic JOSEPH J. ALLEN from Los Angeles Division.

JAMES J. BULGER was transported by the United States Marshal Service (USMS) to ATLANTIC AVIATION, 6411 West Imperial Highway, Los Angeles, California, 90045. Thereafter BULGER was escorted to and seated in the rear area of the Department of Justice (DOJ) G5 Aircraft. BULGER was examined by FEDERAL BUREAU OF INVESTIGATION (FBI) Los Angeles Division medic JOSEPH J. ALLEN. Thereafter, BULGER was provided with a copy of Form FD-597, Receipt For Property, detailing items seized from 1012 Third Street, Apartment 303, Santa Monica, California.

BULGER was then advised of certain Constitutional rights as per form FD-395 entitled "Advice of Rights" to include the waiver portion of the form. BULGER thereafter advised that he would be willing to waive his rights and answer questions at this time. BULGER then signed the FD-395 under the Waiver of Rights portion of the form.

BULGER was advised that he was being interviewed in an effort to obtain information regarding the activities of BULGER and GREIG while they were in fugitive status. BULGER advised that he was willing to cooperate and answer questions in an effort to assist CATHERINE GREIG with her charges. Additionally BULGER advised that he was trying to help JOHN CONNOLLY who BULGER stated had been "framed". BULGER also stated that he felt responsible for JOHN CONNOLLY. BULGER advised that he was actually dealing with JOHN MORRIS and didn't tell anybody about it.

During the interview of BULGER, questioning was limited to the circumstances regarding the activities of BULGER and GREIG during fugitive preparations and activities. Questioning did not address prior substantive acts although BULGER did make statements, without prompting or questioning, outside of the scope of the fugitive investigation.

1). The report from June 24th says that “all BULGER cared about from this point forward was helping clear the name of former FBI SA JOHN CONNOLLY. BULGER believed that CONNOLLY had been framed by former Boston Field Office Assistant Special Agent in Charge over the Organized Crime Task Force JOHN MORRIS.” (Exhibit D, p. 2). Bulger also stated that he had “given much more than \$7000.00 to MORRIS and had been bribing him regularly for information. BULGER stated ‘you can add a couple of zeros to that \$7000.00 number.’” (Exhibit D, p. 2). Bulger also asserted that “he caught wind that he was going to be indicted through contact with former FBI Supervisor JOHN MORRIS,” referring to him as “my guy” and explaining that “a supervisor is a better source of information.” (Exhibit D, p. 3). He later stated that “MORRIS was ‘his partner’ not JOHN CONNOLLY” and that “‘MORRIS was [his] paid FBI informant’ and that he (BULGER) paid money to MORRIS on several occasions.” (Exhibit D, p. 15). On June 27th, Bulger advised another Agent that “he was trying to help JOHN CONNOLLY who BULGER states had been ‘framed.’” (Exhibit D, p. 17). It was further memorialized that “BULGER also states that he felt responsible for JOHN CONNOLLY. BULGER advised that he was actually dealing with JOHN MORRIS and didn’t tell anybody about it.” (Exhibit D, p. 17).

Additional exculpatory statements revealed in Bulger’s manuscript, also not turned over to the defense, read as follows:

1. “Ritchie Castucci was not an informant—he was killed simply because he came over to the garage to collect \$35,000 that Johnnie [Martorano] had lost in betting sporting events for prior weeks. J [Martorano] won and R [Castucci] would drop off the money with a smile and little chatter. . .” (Exhibit C, p. 10).
2. “J [Martorano] on 60 min. says he never killed for \$—This was [Martorano] killing [Castucci] for \$35,000. Later we went to a club [Castucci] had a piece of and told them we would pick up [Castucci]’s end every week and if they didn’t do as we say we will kill the owner.” (Exhibit C, p. 11).
3. **“So unknown to Steve [Flemmi] or [John Connolly] I started to corrupt [John Morris]** - I gave him an envelope with \$ in it he was real nervous and swore me to secrecy - I agreed & never betrayed the promise I made. I set up meets on monthly basis in the City Hall area

& one of us missed the meet the following week same day same time. To make him feel at ease I'd ask him to give me a picture of someone or info so he would feel we were committed." (Exhibit C, p. 22) (emphasis added).

4. **"Some persons + [Morris] always nervous - worried [Connolly] would figure things out.** I tried to calm him down. He worried that the slightest hint would result in him being put on the box. He read everything he could get on how to beat the box— books on how to lie – God he was one nervous devious guy – always scheming and most secretive.
So [Morris] comes up with a scheme to neutralize [Connolly] he tells me how he's going to ask [Connolly] to ask me for some money for him and for me to give it to him – this way if [Connolly] delivers, he's broke the FEDS rules and won't be quick to admit it. I go along with it, another time he says deliver some \$ for him in a wine box so [Connolly] knows. A test to see [Connolly] reaction." (Exhibit C, p. 23) (emphasis added).
5. **"[Morris] was the boss so he could steer investigations and give me info on what was going on in return I provided money. He let me know who fed them information and who gave information on me + [Flemmi]."** (Exhibit C, p. 23) (emphasis added).
6. **"Regarding [Morris] he was a good investment- He told me about John Callahan going to be in front of Grand Jury-** I tried to warn Johnny [McDonald] to change location to no avail..." (Exhibit C, p. 24) (emphasis added).
7. **"[Morris] puts in memos giving me credit for helping the F.B.I.** this to keep heat off me + keep the money coming in..." (Exhibit C, p. 26) (emphasis added).
8. "It took a long time but slowly and surely the feds built a case against us. I had always planned for that eventuality **and when [Morris] tipped me off** I sped out of the picture." (Exhibit C, p. 29) (emphasis added).
9. "All those years I kept [Morris]'s name secure and **I'd always say to others John told me etc. etc. Also time to time I'd make up a story about [Connolly] telling me something** etc just to see if it came back, that would have told me the person talked too much and was a danger that had to be removed. **I am sure everyone close to me thought all the information I had came from [Connolly] I didn't discourage that thought—Sadly for [Connolly] he took the heat for warning me to take off and other things that had come from [Morris]."** (Exhibit C, p. 29) (emphasis added).
10. **"[Morris] tried to get me killed and failed and I suspect he didn't want me to be in custody, fearing I may expose him so he warned me that the indictment came down on me + Steve and make a run for it . . .** Ironic, he helped frame a fellow agent to save himself and warns me to run, saving me, and he hopes himself." (Exhibit C, p. 32) (emphasis added).
11. "[Morris] becomes a star witness against [Connolly] the sacrificial lamb and saves himself. **[Morris] admitted in court I gave him 7000—John at the least, add a couple more zeros.**" (Exhibit C, p. 32) (emphasis added).

This new information is the basis of the following Motion for Post Conviction Relief.
